A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, DECLARING ITS INTENTION TO MODIFY THE DOWNTOWN POMONA PROPERTY AND BUSINESS IMPROVEMENT DISTRICT

WHEREAS, on July 20, 2009 the City Council of the City of Pomona ("City Council") adopted Resolution Number 2009-118 declaring the results of the majority protest proceedings and renewing the Downtown Pomona Property and Business Improvement District ("DPPBID"); and

WHEREAS, the Property and Business Improvement District Law of 1994, Streets and Highways Code §36600 et seq., allows cities to modify the Management District Plan ("MDP") of a District at the request of the Owners' Association; and

WHEREAS, the DPPBID Owners' Association, the Downtown Pomona Owners Association has requested modification of the MDP.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

- 1. The recitals set forth herein are true and correct.
- 2. The City Council declares its intention to modify the DPPBID MDP.
- 3. The proposed modification of the DPPBID MDP will reduce the term of the DPPBID from ten (10) years to nine (9) years, with a modified ending date of December 31, 2018.
- 4. The time and place for a public hearing on modification of the MPBID MDP are set for 7:00 PM or as soon thereafter as the matter may be heard on September 10, 2018 at 505 S. Garey Avenue, Pomona, CA 91766.
- 5. This resolution shall take effect immediately upon its adoption by the City Council.
