**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, APPROVING AN AMENDMENT AND EXTENSION OF THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF POMONA AND THE POMONA POLICE MANAGERS' ASSOCIATION FOR THE PERIOD OF JULY 1, 2017 THROUGH JUNE 30, 2019**

**WHEREAS**, the current Memorandum of Understanding between the City of Pomona and the Pomona Police Managers' Association (PPMA) expired on June 30, 2017;

**WHEREAS**, City representatives negotiated a tentative agreement with the PPMA, which, if approved, will be for an amendment and extension of the MOU for the period of July 1, 2017 through June 30, 2019; and

**WHEREAS**, the City Council has the authority to approve and ratify a contract with the City's employee associations.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona, California as follows:

**SECTION 1.** That the Amendment and Extension of the 2016-17 Memorandum of Understanding between the City of Pomona and the PPMA for the period of July 1, 2017 through June 30, 2019, attached hereto as Exhibit A, shall be approved, ratified, and ordered implemented.

**SECTION 2.** That the City Manager of the City of Pomona is hereby authorized, empowered, and directed to enter into this Agreement for and on behalf of the City of Pomona.

**SECTION 3.** That the City Clerk is directed to attest the execution of the Amendment and Extension to the 2016-17 Memorandum of Understanding.

**SECTION 4.** That the City Clerk shall certify to the passage and adoption of this resolution, and it shall become effective immediately upon its adoption.
