

RESOLUTION NO. 2018-

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA
APPROVING THE CANCELLATION AND RESCHEDULING OF
MEETINGS AND ESTABLISHING THE RESCHEDULED MEETING
DATES AS “REGULAR” MEETINGS OF THE CITY COUNCIL**

WHEREAS, Section 503 of the Pomona City Charter requires that regular meetings of the City Council be established by ordinance or resolution;

WHEREAS, the City Council adopted Resolution No. 2004-32, which establishes the first and third Monday of each month for regular meetings and the second Monday of each month for Study Sessions, as necessary;

WHEREAS, due to holidays and other scheduling conflicts that fall on the same day as regularly scheduled meetings, it would be in the best interest of the City to reschedule or cancel certain regular meetings in order to allow the conduct of the City’s business; and,

WHEREAS, the City Council desires to reschedule or cancel regular meetings as listed below in the 2018 calendar year that conflict with recognized City holidays or other scheduled events.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The regular City Council meeting scheduled for January 21, 2019, is hereby cancelled and rescheduled to Monday, January 28, 2019, to be conducted as a regularly scheduled meeting of the City Council.

SECTION 2. The regular City Council meeting scheduled for February 18, 2019, is hereby cancelled and rescheduled to Monday, February 25, 2019, to be conducted as a regularly scheduled meeting of the City Council.

SECTION 3. The regular City Council meeting scheduled for September 2, 2019, is hereby cancelled and rescheduled to Monday, September 9, 2019.

SECTION 5. All other City Council meeting dates established in accordance with Resolution No.2004-32 remain unchanged unless otherwise rescheduled by resolution.

SECTION 6. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
