Subject: **Approve the Purchase of Four (4) Towable Air Compressors from Volvo Construction Equipment and Service, in the Total Amount of \$109,892; Utilizing National Joint Powers Alliance Contract Agreement Number 052015-CEC**

OVERVIEW

Recommendations - That the City Council approve the purchase of four (4) towable air compressors from Volvo Construction Equipment and Service, in the total amount of \$109,892, utilizing National Joint Powers Alliance (NJPA) contract agreement number 052015-CEC.

Fiscal Impact - The total fiscal impact for the proposed action is \$109,892; funded from the Water Fund (571-8124-66193-00000). Utilizing the National Joint Powers Alliance (NJPA) contract agreement number 052015-CEC (Attachment) provides an expedited purchasing process, competitive pricing, and a discount of 36% off the list price, a markdown of \$12,963 per unit.

Previous Related Action – None.

EXECUTIVE SUMMARY

The recommended action will replace a total of four (4) towable air compressor units which are part of the City's Water Resources Department's fleet. All four of the towable air compressors scheduled for replacement meet or exceed the City's adopted Vehicle Replacement Policy criteria. Most of the towable air compressors have substantial failure issues, are unreliable, and require frequent repairs. This action will approve a purchase to Volvo Construction Equipment and Service for four (4) towable air compressors in the total amount of \$109,892.

DISCUSSION

On April 4, 2016, the City Council adopted a revised Vehicle Replacement Policy and Procedures report establishing criteria to justify the purchase of replacement vehicles and other equipment citywide. Within the category of Other Equipment is the City's construction

equipment. Construction equipment is generally taken out of service when at least one of the following conditions exists: the equipment reaches the end of its useful life; the equipment incurs collision damage requiring substantial repair expense relative to replacement cost; or when equipment maintenance costs become inefficient due to age-related factors, including parts availability, emission control, and mechanic hours.

Two (2) of the towable air compressor units exceeded the end of their useful life for their respective construction equipment descriptions. The following table (Table 1) provides details on the construction equipment recommended for replacement, as they meet the required criteria under the City's adopted Vehicle Replacement Policy and Procedures:

The Fleet and Facilities Services Manager has reviewed and approved the proposed replacement of towable air compressors. The towable air compressors listed in Table 1 will be retired from the Water Resources Department and turned over to the Fleet Department in preparation for auction or repurposing to another City department at the discretion of the Fleet Services Manager. The requested replacements meet all current Federal emissions requirements.

Pomona City Code §2-973, Cooperative Purchasing allows for the procurement of goods and services through contracts entered into by other governmental agencies that went through a competitive bid process. This procurement process reduces staff time in developing and analyzing bids and provides competitive pricing. Doosan Portable Power Equipment was awarded a contract under NJPA Contract Agreement Number 052015-CEC. Volvo Construction Equipment and Service is a Doosan Portable Power Equipment local authorized dealer for this region; therefore, it will serve as the authorized delivering dealer for this purchase.
