## **OVERVIEW**

**Recommendation** – That the City Council adopt a Resolution (Attachment 1):

- 1. Approve submittal of one application for the MSRC 2017 Local Government Partnership Program for the purchase of various Near-Zero and Zero Emission, Light Duty, Medium Duty, and Heavy Duty Vehicles requesting a grant in the amount of \$200,140 with match determined by type of vehicle; and
- 2. Authorizing Staff to submit future applications under the Mobile Source Air Pollution Reduction Review Committee (MSRC) Local Government Partnership Program as opportunities are identified; and
- 3. Authorize the City Manager to execute all related documents.

**Fiscal Impact** – The City is eligible to receive up to \$200,140 from MSRC by way of the 2017 Local Government Partnership Program. MSRC will match from 25% to 50% of the purchase cost of Near-Zero and Zero Emission Vehicles, with a maximum dollar amount depending on vehicle type. It is anticipated that the City's match will be funded by various City funds including AQMD Subvention Funds, Measure M Funds, Solid Waste, Water Funds, and/or other funds.

## **EXECUTIVE SUMMARY**

This action will enable the City to reserve \$200,140 (maximum amount available to Pomona) in MSRC 2017 Local Government Partnership Program grant funds. The program is designed to emphasize an accelerated transition to zero and near zero emission vehicles along with essential supporting infrastructure. The City's match will depend on the type of zero and/or near-zero vehicle(s) purchased.

## **DISCUSSION**

The Local Government Partnership Program provides additional funding, beyond funding provided through AB 2766 Subvention Fund Program to assist local agencies in implementing high priority clean air programs. The program emphasizes an accelerated transition to zero and near zero vehicles along with essential infrastructure. Funding is provided on a reserve basis, and not a competitive basis for all agencies that participate in the AB2766 Program. The City of Pomona has a reserve funding amount of \$200,140.

The MSRC established the below project categories that Pomona has the ability to utilize through the Local Government Partnership Program:

- Light-Duty Zero Emission Vehicle Purchases or Leases
- Medium & Heavy-Duty Zero Emission Vehicle Purchases
- Near-Zero Emission Heavy-Duty Alternative Fuel Vehicle Purchases & Repowers
- Electrical Vehicle Charging Station Installation
- Alternative Fuel Refueling Infrastructure New Construction or Expansion

The application submittal period closes on August 2, 2018 (grant submission period was extended by AQMD for various reasons). MSRC provides a twelve (12) month period from the date of receipt of an application by MSRC to negotiate and execute a contract to complete the proposed project(s). Projects funded through this program are required to be completed within 60 months.

To participate in the program, the City must complete all requirements outlined in the MSRC's Local Government Partnership Program Opportunity Notice and Invitation to Negotiate (Attachment 2), including providing the MSRC's Local Government Partnership Program presentation to City Council, adopting a proposed resolution formally acknowledging receipt of the MSRC presentation, authorizing the proposed project(s), allocating the necessary matching funds, and submitting an application describing the project implementation plan, proposed budget, and project implementation schedule.

Currently, the City has a proposed project application to submit to the MSRC for the Local Government Partnership Program (Attachment 3). The proposal will include purchase of various

near-zero and zero emission vehicles. The grant amount requested is \$200,140, with the City contributing matching funds based on type of vehicle(s) from various sources such as AQMD Subvention funds, Measure M, Solid Waste, Sewer, Water, and/or other funds.
