

RESOLUTION NO. 2018-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA APPROVING A \$24,500 CONTRIBUTION FROM THE VEHICLE PARKING DISTRICT (VPD) FISCAL YEAR 2018-2019 BUDGET TO THE DOWNTOWN POMONA OWNERS ASSOCIATION (DPOA) FOR THE PURCHASE AND INSTALLATION OF SECURITY SURVEILLANCE CAMERAS AND SUPPORTING EQUIPMENT TO PROVIDE ADDITIONAL SECURITY SURVAILLANCE TO VPD LOTS 3, 5, 7 10, 11 AND ADJACENT DOWNTOWN AREAS

WHEREAS, the Vehicle Parking District (VPD) Board of Parking Place Commissioners desire to enhance security in VPD parking lots by providing surveillance of the parking lots 24 hours a day 7 days a week;

WHEREAS, the Vehicle Parking District Board of Parking Place Commissioners received a request from the Downtown Pomona Association for a \$24,500 contribution toward the purchase and installation of seven (7) new security surveillance cameras and linkage radios in the Downtown that will cover VPD parking lots 3, 5, 7, 10, 11 and the surrounding streets, alleys and building exteriors;

WHEREAS, on May 10, 2018, the Vehicle Parking District Board of Parking Place Commissioners, after extensive review and discussion, determined that a contribution of \$24,500 from the VPD Fiscal Year 2018-2019 budget would benefit the Vehicle Parking District by enhancing security and safety in the parking lots;

WHEREAS, Vehicle Parking District Fiscal Year 2018-2019 budget a sufficient amount for the recommended contribution for additional security surveillance cameras:

WHEREAS, although the Vehicle Parking District Board of Parking Place Commissioners approved the DPOA's request for the contribution, the requested amount exceeds the VPD's contribution authority pursuant to the VPD's contribution policy, which states that contribution requests in excess of \$1,000 shall be subject to City Council approval;

WHEREAS, the Vehicle Parking District Board of Parking Place Commissioners thus recommends that the City Council approve such contribution to the Downtown Pomona Owners Association for the purchase and installation of seven (7) security surveillance cameras and linkage routers; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council hereby approves a \$24,500 contribution from the Vehicle Parking District FY 2018-2019 Operating Budget to the Downtown Pomona Owners Association for the purchase of seven (7) new security surveillance cameras and linkage radios to cover VPD parking lots 3, 5, 7, 10, 11 and adjacent Downtown areas.

SECTION 2. The City Clerk shall attest and certify to the passage and adoption of this Resolution and it shall become effective immediately upon its approval.
