The CUP is specifically for the addition of a 1,392 square foot employee lounge and legalization of 6 engineered shade canopies. The employee lounge is needed to accommodate current employees and does not represent an expansion or intensification of the current operations of the business. The canopies are to correct for code violation. The conditions as set forth by the Planning Department staff PC Resolution have been reviewed and is fully acceptable by the owner.
