Environmental Construction, Inc. ("ECI") hereby protests the bids submitted by CEM Construction Corporation and by California Landscape & Design, Inc. on June 27, 2018 for the above-noted project. Both firms submitted non-responsive bids. Accordingly, the project should be awarded to ECI, the lowest responsive, responsible bidder.

CEM Construction Corporation's Non-Responsive Bid

CEM Construction Corporation ("CEM") submitted a non-responsive bid proposal. CEM did not notarize its Noncollusion Affidavit. The affidavit form required that bidders affix both a notary seal and a certificate of acknowledgment. CEM had the form stamped by a notary but did not affix a certificate of acknowledgment. See Attachment 1. Civil Code Section 1189 requires that a notary's certificate of acknowledgment include specific language. See Attachment 2. Government Code Section 8202(b) requires that a sworn affidavit be acknowledged with a notary's jurat that includes specific language. See Attachment 3. CEM did not comply. Public contract bids are invalid without a sworn non-collusion affidavit. Public Contract Code Section 7106. Because CEM did not notarize its Noncollusion Affidavit, its bid is non-responsive and should be rejected as such.

CEM provided false information on its submitted Information Required of Bidders form. When asked to list the names and titles of all corporate officers, CEM identified Jesus Carrillo as President and Secretary; and identified Emigdio Carrillo as Vice President and Treasurer. See Attachment 4. In fact, CEM's filings with the California Secretary of State show that Emigdio Carrillo is CEM's Secretary, not Jesus Carrillo, and that Jesus Carrillo is CEM's CFO. See Attachment 5. Because it submitted false corporate information in its bid proposal, CEM's bid is non-responsive and should be rejected as such.

CEM did not complete the "Contractor as Claimant or Plaintiff" portion of its submitted Questionnaire form. The form asked two (2) questions about each bidder's history of initiating litigation against project owners. CEM did not answer either question. See Attachment 6. Because it did not answer all questions in the Questionnaire portion of its bid proposal, CEM's bid is non-responsive and should be rejected as such.

California Landscape & Design, Inc.'s Non-Responsive Bid

California Landscape & Design, Inc. ("CLD") submitted a non-responsive bid proposal. CLD listed Carrillo Electric, Inc. as its electrical subcontractor. See Attachment 7. Carrillo Electric is not registered with the California Department of Industrial Relations. See Attachment 8. Because it listed an electrical contractor without an active DIR registration, CLD's bid is non-responsive and should be rejected as such.

Because CEM Construction Corporation and California Landscape & Design, Inc. submitted non-responsive bids, both bids should be rejected as such and the project should be awarded to ECI, the lowest responsive, responsible bidder.
