

RESOLUTION NO. 2018-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING THE ACCEPTANCE AND APPROPRIATION OF A \$27,500 DONATION FROM THE POMONA COMMUNITY FOUNDATION TO FUND AN ANNUAL CONTRACT WITH HEALTHIFY AKA PURPLE BINDER, TO PROVIDE ON-LINE PUBLIC ACCESS TO A VOLUNTARY RESOURCE DATA BASE OF THE SUPPORTIVE SERVICES AVAILABLE TO THE POMONA COMMUNITY

WHEREAS, the City has provided the Pomona community at large access to local service provider (agencies, non-profits, non-governmentals) information by annually contracting \$27,500 for on-line web services for 1 year; and

WHEREAS, fiscal constraints in the FY 2018/19 Pomona General Fund Operating Budget did not permit the \$27,500 contract amount to be appropriated; and

WHEREAS, upon being informed of the loss of this service, a number of donors and community partners have pledged to contribute necessary funds to the Pomona Community Foundation (PCF) as an intended donation to fund a continuation of the annual contract for FY 2018/19;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. Authorize the acceptance of \$27,500 (101-1304-40845-00000) collected by the Pomona Community Foundation (PCF) from various local donors and Pomona community partners, and appropriate the same amount in the Government and Community Affairs budget (101-1304-52285-00000) to fund an annual service contract providing a voluntary data base of the supportive services available to the Pomona community;

SECTION 2. Authorize a Professional Services Agreement with Healthify in the amount of \$27,500 to provide on-line services for FY 2018/19. .

SECTION 3. Authorize the City Manager to execute the appropriate contracts and other documentation requested for acceptance of the award and operation of the above listed agreement subject to approval as to form by the City Attorney.

SECTION 4. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
