

**RESOLUTION NO. 2018 - \_\_\_\_\_**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA MODIFYING  
THE DOWNTOWN POMONA PROPERTY AND BUSINESS IMPROVEMENT  
DISTRICT**

**WHEREAS**, on July 20, 2009 the City Council of the City of Pomona (“City Council”) adopted Resolution Number 2009-118 declaring the results of the majority protest proceedings and renewing the Downtown Pomona Property and Business Improvement District (“DPPBID”); and

**WHEREAS**, the Property and Business Improvement District Law of 1994, Streets and Highways Code §36600 et seq., allows cities to modify the Management District Plan (“MDP”) of a District at the request of the Owners’ Association; and

**WHEREAS**, the DPPBID Owners’ Association, the Downtown Pomona Owners’ Association has requested modification of the MDP; and

**WHEREAS**, on August 6, 2018 the City Council adopted a Resolution of Intention to Modify the Management District Plan of the DPPBID, Resolution number 2018-110 (the “Resolution of Intention”); and

**WHEREAS**, the Resolution of Intention was published and mailed in accordance with Streets and Highways Code Section 36636; and

**WHEREAS**, a public hearing on the proposed modification was held on September 10, 2018.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL THAT:**

1. The recitals set forth herein are true and correct.
2. The City Council hereby modifies the DPPBID MDP. The modification of the DPPBID MDP will reduce the term of the DPPBID from ten (10) years to nine (9) years, so that the term of the District ends on December 31, 2018.
3. This resolution shall take effect immediately upon its adoption by the City Council.
