

RESOLUTION NO. 2018-_____

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA AMENDING THE FY 2018-19 POLICE SPECIAL FUNDS BUDGET BY APPROPRIATING \$134,206 OF UNSPENT/CARRYOVER SLESA PROJECT FUNDS FROM FY 2016-17 AND FY 2017-18, AMENDING THE FY 2017-18 SLESA EXPENDITURE PLAN AND AWARDING A PURCHASE CONTRACT

WHEREAS, the Pomona Police Department receives Vehicle License Fee (VLF) funds from the State each year;

WHEREAS, in FY 2017-18, the City received approximately \$94,075 more than the State's original projection of \$238,000;

WHEREAS, those funds have gone unspent and have not been appropriated in the current fiscal year budget; and,

WHEREAS, the authority to amend the FY 2018-19 Police Special Funds Budget and appropriate unspent SLESA monies, amend the FY 2017-18 SLESA Expenditure Plan and award a purchase contract is vested with the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. That the City Council hereby amends the Police Department's FY 2018-19 Police Special Funds Budget.

SECTION 2. That the City Council hereby appropriates \$134,206 of unspent/carryover FY 2016-17 (281-2090-XXXXX-58661) and FY 2017-18 (281-2090-XXXXX-58764) SLESA project monies into the FY 2018-19 Police Special Funds Budget.

SECTION 3. That the City Council hereby amends the FY 2017-18 SLESA Expenditure Plan to include the proposed modifications.

SECTION 4. That the City Council hereby awards a purchase contract to National Auto Fleet Group in an amount not to exceed \$68,325.

SECTION 5. That the City Clerk shall attest and certify to the passage and adoption of this resolution and it shall be effective immediately upon its approval.
