SUBJECT: TIME EXTENSION (EXT 8827-2017):

Request for a one-year time extension for Conditional Use Permit (CUP 5251-2016) to allow the sale of alcoholic beverages (on-sale beer and wine – Type 41 ABC license) for on-site consumption in conjunction with an existing restaurant (Wingstop) located at 2063 Rancho Valley Drive, Suite 300 in the C-4 (Highway

Commercial district.

STAFF RECOMMENDATION

The Planning Division recommends that the Planning Commission approve Time Extension (EXT 8827-2017) granting a one-year time extension for Conditional Use Permit (CUP 5251-2016) subject to the conditions of PC Resolution No. 16-031 approved on October 26, 2016 (Attachment 1).

PROJECT DESCRIPTION & BACKGROUND

On October 26, 2016, applicant, Lil Mama Enterprises, Inc. received Planning Commission approval for Conditional Use Permit (CUP 5251-2016) to allow the sale of alcoholic beverages (on-sale beer and wine – Type 41 ABC license) for on-site consumption in conjunction with an existing restaurant (Wingstop). On October 25, 2017, the applicant submitted a request to the Planning Division for a one-year time extension for Conditional Use Permit (CUP 5251-2016). The applicant was not able to exercise the subject entitlement by the October 25, 2017 deadline.
