RESOLUTION NO. 2018-X

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AFFIRMING THE GUIDING PRINCIPLES OF THE "SAN GABRIEL VALLEY POSITIONS ON HOMELESS HOUSING, SHELTER AND SERVICES PROVISION" AS ADOPTED BY THE GOVERNING BOARD OF THE SAN GABRIEL VALLEY COUNCIL OF GOVERNMENTS.

- **WHEREAS,** on September 21, 2017, the San Gabriel Valley Council of Governments (SGVCOG) Governing Board voted to accept a contract with the County of Los Angeles to coordinate regional homeless services in the San Gabriel Valley;
- **WHEREAS,** nineteen-member agencies of the SGVCOG have created homeless plans to address homelessness within their respective jurisdictions;
- **WHEREAS**, the San Gabriel Valley is within the Greater Los Angeles Continuum of Care which has the greatest number of unsheltered people in the nation;
- **WHEREAS**, the challenge of homelessness is too complex for any one city to manage independently;
- **WHEREAS,** member cities have conferred to develop a platform for fair and equitable provision of homeless services and housing within the San Gabriel Valley;
- **WHEREAS**, on August 1, 2018, the Governing Board of the San Gabriel Valley Council of Governments adopted the "San Gabriel Valley Positions on Homeless Housing, Shelter and Services Provision" as a guiding document;
- **WHEREAS**, it has been determined by the SGVCOG Governing Board that their member agencies should respect the adoption of the "San Gabriel Valley Positions on Homeless Housing, Shelter and Services Provision" by other member agencies; and
- **WHEREAS**, the "San Gabriel Valley Positions on Homeless Housing, Shelter and Services Provision" support the City of Pomona's strategic plan "A Way Home".
- NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:
- **SECTION 1.** Exhibit A to this Resolution entitled "San Gabriel Valley Positions on Homeless Housing, Shelter and Services Provision", incorporated herein by reference, is hereby affirmed as providing guiding principles to address homelessness within the San Gabriel Valley Region.
- **SECTION 2.** Authorizes the City Manager to execute any agreements or documentation requested in support of this resolution, approved as to form by the City Attorney.
