

RESOLUTION NO.2018-

A RESOLUTION AUTHORIZING THE ACCEPTANCE OF SEVENTEEN VOUCHERS, FUNDED BY THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT'S (HUD) SECTION 811 MAINSTREAM VOUCHER PROGRAM, IN THE AMOUNT OF \$233,432, TO OPERATE THE POMONA MAINSTREAM VOUCHER PROGRAM, EFFECTIVE NOVEMBER 1, 2018

WHEREAS, the Omnibus Appropriations Act, 2017 made approximately \$13 million available for new Section 811 Housing Choice Vouchers (known as Mainstream Vouchers) to assist non-elderly persons with disabilities; and,

WHEREAS, HUD awarded the 2017 funding and a portion of the 2018 funding through Notice of Funding Availability Number FR-6100-N-43; and

WHEREAS, on September 5, 2018, the Pomona Housing Authority was awarded seventeen (17) Mainstream vouchers to assist non-elderly disabled persons within the PHA's jurisdiction, with the program to be effective November 1, 2018; and

WHEREAS, rental assistance and supportive services provided through the Mainstream program are a critical resource for local communities in ending homelessness among our nation's disabled; and

WHEREAS, the Mainstream program is administered in accordance with regular Housing Choice Voucher (HCV) program requirements found at 24CFR Section 982; and

NOW, THEREFORE, BE IT RESOLVED by the City Council, sitting as the Governing Board of the Pomona Housing Authority, as follows:

SECTION 1. Authorizes the acceptance of seventeen (17) Section 811 Mainstream Vouchers, worth \$233,432 in annual funding from HUD to operate a tenant-based Mainstream Voucher Program; and

SECTION 2. Amends the FY 2018-2019 Operating Budget by receiving and appropriating \$214,664 in rental assistance to non-elderly disabled persons and approximately \$18,768 for administrative costs in fund 205-1791-XXXXX-59009; and

SECTION 3. Amends the Section 8 Housing Choice Voucher Administrative Plan to comply with 24 CFR 982; and

SECTION 4. Authorize the City Manager, as Executive Director of the Pomona Housing Authority, to execute the appropriate contracts and other documentation requested for acceptance of the award and operation of the above listed program to HUD, subject to approval as to form by the City Attorney; and

SECTION 5. That the Pomona Housing Authority Secretary shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
