## **RESOLUTION NO. 2018-**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, AMENDING THE 2018-19 GENERAL FUND OPERATING BUDGET BY APPROPRIATING \$47,250 FROM GENERAL FUND RESERVE BALANCE TO ACCOUNT NUMBER 101-0101-52285-51331;

- **WHEREAS**, the City Council is prescribed the authority the by Charter of the City of Pomona to adopt Operating budgets;
- **WHEREAS**, Assembly Bill 117 authorized the creation of Community Choice Aggregation (CCA) allowing cities, counties, and other authorized entities to aggregate electricity demand within their jurisdictions in order to purchase and/or generate alternative energy supplies for residents, businesses, and their own facilities, while maintaining the existing electricity provider for transmission and distribution of services;
- **WHEREAS**, On February 5, 2018, staff presented other CCA options, and City Council voted to move forward with the initial feasibility study to identify and analyze technical parameters of the CCA Program;
- **WHEREAS**, California Choice Energy Authority (CCEA) demonstrated a strong understanding of the scope and showcased exceptional quality of past work with other government agencies such as the City of Lancaster, the first CCA city in Southern California;
- **WHEREAS**, the cost to complete the CCA formation, implementation plan, ordinance, and statement of intent to form the CCA is \$63,000;
- **WHEREAS**, funding for the study will be split between the Water Fund (25%, \$15,750 account #571-8122-52285-51331) and General Fund (75%, \$47,250 account #101-0101-52285-51331); and
- **WHEREAS**, the City Council desires to amend the 2018-19 General Fund by \$47,250 account #101-0101-52285-51331, to make the necessary funds available.
- **NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:
- **SECTION 1.** That the City Council hereby amend the 2018-19 General Fund Operating Budget by appropriating \$47,250 from General Fund Reserve Balance to Account Number 101-0101-52285-51331.
- **SECTION 2.** That the City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
