RESOLUTION NO. 2018-

A RESOLUTION OF THE CITY COUNCIL, OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FISCAL YEAR 2018-2019 VEHICLE PARKING DISTRICT OPERATING BUDGET BY APPROPRIATING \$13,500 FROM THE VEHICLE PARKING DISTRICT FUND BALANCE TO PAY FOR PARKING PAYMENT KIOSK BACK OFFICE SOFTWEAR AND CREDIT CARD TRANSCATION SUPPORT SERVICES

WHEREAS, the Board of Parking Place Commissioners (commonly referred to in the City of Pomona as the "Vehicle Parking District [VPD] Commission") is established pursuant to the Vehicle Parking Law of 1943 (California Streets and Highways Code Sections 31500 *et seq.*), and Chapter 58, Article VI of the Pomona City Code. Pursuant to Streets and Highways Code;

WHEREAS, under California law, the VPD Commission has broad authority to control and manage the operation of the parking places within the VPD;

WHEREAS, the VPD Commission is authorized to manage, operate, repair, maintain, and otherwise control parking places, and enforce all necessary regulations for the use of the VPD parking lots;¹

WHEREAS, the VPD Commission has determined that, within the parameters of the Vehicle Parking District Law of 1943, the method by which VPD parking permits are sold is within the authority granted by State law for the management, operation and control of VPD parking places;

WHEREAS, the VPD currently owns and utilizes T2/Digital Payment Technology parking payment kiosks to collect daily parking fees;

WHEREAS, operation of the parking payment kiosks requires back office electronic communications services, which are provided by T2/Digital Technologies at a cost to the VPD of \$13,500 per year; and

WHEREAS, on October 11, 2018, the VPD Commission voted unanimously to recommend City Council approval for amending the VPD Fiscal Year 2018-2019 Operating Budget by appropriating \$13,500 to pay for T2/Digital Payment Technologies back office software and credit card payment support services.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The above recitals are true and correct and shall be relied upon for the action to be taken herein.

SECTION 2. The City Council hereby approves an amendment to the Vehicle Parking District's Fiscal Year 2018-2019 Operating Budget by appropriating \$13,500 from the VPD fund

balance for the purpose of making funds available for payment to T2/Digital Payment Technologies for parking payment kiosk back office electronic software and credit card processing services to continue operations of the parking payment machines.

SECTION 3. The City Clerk shall attest to the passage of this resolution, and it shall become effective immediately upon its adoption.
