## **RESOLUTION NO. 20XX-**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, DESIGNATING \$321,930 IN MENTAL HEALTH SERVICES ACT FUNDING FROM TRI CITY MENTAL HEALTH CENTER TO VOLUNTEERS OF AMERICA LOS ANGELES AS THE SUB-RECIPIENT UNDER THE HOPE FOR HOME HOMELESS SERVICE CENTER SITE OPERATOR AGREEMENT

- **WHEREAS**, on July 17, 2017, City Council approved an award of contract to Volunteers of America Los Angeles (VOALA) as the selected site operator of the Hope for Home Homeless Service Center for an initial 5-year period; and,
- **WHEREAS**, as the selected site operator, VOALA was also designated as the subrecipient of future funds identified and/or received by the City of Pomona to operate the Hope for Home Homeless Service Center for the same period of time; and,
- **WHEREAS**, on August 6, 2018, City Council authorized acceptance of \$357,700 in Mental Health Services Act (MHSA) funding from Tri City Mental Health Center (Tri City) to reserve 28 beds at the Hope for Home Homeless Services Center and authorized the City to enter into a MHSA funding agreement with Tri City; and,
- **WHEREAS**, it has been determined that the City is able to utilize the awarded MHSA funds for the operation of the Homeless Services Center and delivery of service to the referred MHSA clients; and,
- **WHEREAS,** the amount of \$321,930 in MHSA funding has been identified by the City of Pomona to operate the Hope for Home Homeless Service Center to provide crisis housing beds for homeless clients at the referral of Tri City Mental Health Center; and,
- **WHEREAS,** \$207,760 of these funds will be used in the operation of 28 crisis beds from December 1, 2018 through June 30, 2019 and the balance of \$114,170 will be used by VOALA to assist with costs necessary to start-up the Homeless Service Center.
- **NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:
- **SECTION 1**. Approve a resolution designating \$321,930 in Mental Health Service Act funding to VOALA as the sub-recipient under the Hope For Home Homeless Service Center Site Operator Contract, related to an obligation to provide 28 beds to Tri City Mental Health Center from December 1, 2018 to June 30, 2019 for eligible homeless clients at the Hope for Home Homeless Services Center pursuant to the MHSA funding agreement with Tri City.
- **SECTION 2.** Authorize the City Manager to sign all documents necessary to transfer funds, subject to approval as to form by the City Attorney.
- **SECTION 3**. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
