A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA APPROVING THE POLICE DEPARTMENT'S EXPENDITURE PLAN FOR FY 2018-19 SUPPLEMENTAL LAW ENFORCEMENT SERVICES ACCOUNT (SLESA) FUNDING IN THE AMOUNT OF \$236,617, AMENDING THE FY 2018-19 OPERATING AND CIP BUDGETS, UNAPPROPRIATING \$166,775 OF ASSET FORFEITURE FUNDS OUT OF CAPITAL IMPROVE PROGRAM (CIP) "POLICE—DISPATCH RADIO CONSOLE UPGRADE," PROJECT NO. 428-2590-XXXXX-71055 AND APPROPRIATING \$166,775 OF FY 2018-19 SLESA FUNDS INTO CIP "POLICE—DISPATCH RADIO CONSOLE UPGRADE," PROJECT NO. 428-2590-XXXXX-71055

WHEREAS, pursuant to State of California Government Code Section 30061–30063, counties and cities annually receive allocated funds to be deposited into a Supplemental Law Enforcement Services Account (SLESA) to provide assistance to local law enforcement agencies to enhance front-line crime fighting capabilities;

WHEREAS, the City of Pomona is required to adopt an expenditure plan for SLESA funds received from the State of California; and,

WHEREAS, the authority to amend the current operating and CIP budgets to appropriate FY 2018-19 SLESA funds received is vested with the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. That the City Council hereby approves the Police Department's expenditure plan for FY 2018-19 Supplemental Law Enforcement Services Account (SLESA) funds, as stated herein.

SECTION 2. That the City Council hereby amends the FY 2018-19 Police Department SLESA revenue estimate to increase by \$236,617 (281-2090-40873-58690).

SECTION 3. That the City Council hereby amends the FY 2018-19 Police Department Operating budget to appropriate an additional \$236,617 (281-2090-00000-58690) in SLESA monies.

SECTION 4. That the City Council hereby amends the FY 2018-19 CIP budget by unappropriating \$166,775 of Asset Forfeiture funds out of CIP "Police—Dispatch Radio Console Upgrade," Project No. 428-2590-XXXXX-71055.

SECTION 5. That the City Council hereby amends the FY 2018-19 CIP budget by appropriating \$166,775 of FY 2018-19 SLESA funds into CIP "Police—Dispatch Radio Console Upgrade," Project No. 428-2590-XXXXX-71055.

SECTION 6. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall be effective immediately upon its approval.
