A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, RETROACTIVELY AMENDING THE FY 2017-18 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY REAPPROPRIATING \$1,125,749 SERIES “AX” BOND FUNDS (GAREY VILLAGE SALE PROCEEDS) FROM “HOLT AVENUE (WEST) RECONSTRUCTION,” PROJECT NO. 428-2590-XXXXX-71047 TO “MAJOR STREET REHABILITATION CITYWIDE (FY 13-14 TO FY 15-16),” PROJECT NO. 428-2590-XXXXX-68548, “STREET PRESERVATION-CITYWIDE (FY 16-17),” PROJECT NO. 428-2590-XXXXX-67920, “TRAFFIC SIGNAL-VILLAGE LOOP ROAD AND SANTA CLARA DRIVE,” PROJECT NO. 419-2590-XXXXX-50405, AND “TRAFFIC SIGNAL IMPROVEMENTS-TOWNE AVENUE AND RIVERSIDE DRIVE,” PROJECT NO. 428-2590-XXXXX-68553, AND APPROPRIATE A COMBINED \$1,125,749 OF PROP C AND MEASURE R FUNDS FROM THOSE CIP PROJECTS TO “HOLT AVENUE (WEST) RECONSTRUCTION,” PROJECT NO. 428-2590-XXXXX-71047

WHEREAS, the City Council desires to unappropriate a combined \$1,125,749 of Measure R and Prop C funds from “Major Street Rehabilitation Citywide (FY 13-14 to FY 15-16),” Project No. 428-2590-xxxxx-68548, “Street Preservation - Citywide (FY 16-17),” Project No. 428-2590-xxxxx-67920, “Traffic Signal -Village Loop Road and Santa Clara Drive,” Project No. 419-2590-xxxxx-50405, and “Traffic Signal Improvements-Towne Avenue and Riverside Drive,” Project No. 428-2590-xxxxx-68553 and appropriate a combined \$1,125,749 of Measure R and Prop C Funds to “Holt Avenue (West) Reconstruction,” Project No. 428-2590-xxxxx-71047; and

WHEREAS, the City Council desires to unappropriate \$1,125,749 of Series “AX” Bond Funds (Garey Village Foreclosure Sale Proceeds) from “Holt Avenue (West) Reconstruction,” Project No.428-2590-xxxxx-71047, and to appropriate \$1,125,749 of Series “AX” Bonds (Garey Village Foreclosure Sale Proceeds formerly known as “AI” Bonds) to “Major Street Rehabilitation Citywide (FY 13-14 to FY 15-16),” Project No. 428-2590-xxxxx-68548, “Street Preservation - Citywide (FY 16-17),” Project No. 428-2590-xxxxx-67920, “Traffic Signal - Village Loop Road and Santa Clara Drive,” Project No. 419-2590-xxxxx-50405, and “Traffic Signal Improvements – Towne Avenue and Riverside Drive,” Project No. 428-2590-xxxxx-68553.
