### CITY ATTORNEY REPORT OUT FROM CLOSED SESSION

Assistant City Attorney Andrew Jared reported the City Council had convened into Closed Session at 6:10 p.m. with all members present except Councilmember Escobar who arrived at 6:20 p.m. He stated that the items listed on the agenda had been announced prior to recessing into Closed Session, with no public present, and reported the following:

Item A: Discussion took place regarding the City Clerk vacancy. Human Resources Director Linda Matthews sought direction from the City Council, and a Special Meeting for interviews was set for October 22 at 4:00 p.m. upon confirmation from the applicants.

The City Council recessed from Closed Session at 6:25 p.m.

# PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was led by Councilmember Robledo.

Mayor Sandoval requested the order of the agenda be changed by moving Item 5 prior to presentations.

MOTION BY COUNCILMEMBER CARRIZOSA, SECOND BY MAYOR SANDOVAL, CARRIED 6-0, changing the order of the agenda to hear Item 5 at this time.

**5.** City Council Vacancy for District Four and Consideration of Re-Appointment of Councilmember Elizabeth Ontiveros-Cole

Assistant City Attorney Jared advised the City Council regarding Councilmember Ontiveros-Cole's retirement from the Pomona Unified School District. He informed that in order to receive her CALPERS retirement, CALPERS requires that she also retire from her public service on the City Council because the City of Pomona is a CALPERS agency. The City Charter allows for her to be re-appointed to Council.

Elizabeth Ontiveros-Cole spoke about her resignation from City Council as a formality because it was a requirement of the CALPERS retirement system. She expressed a desire to complete her term and requested to be re-appointed.

Julia Cortes and Bryan Marino submitted speaker cards in support of Elizabeth Ontiveros-Cole's re-appointment to the City Council but did not wish to speak.

Discussion ensued regarding the re-appointment of Elizabeth Ontiveros-Cole. All Councilmembers expressed support for their colleague. However, some Councilmembers had concerns regarding the procedural issues and asked to continue discussion until the next Council meeting on October 1 to ensure the re-appointment was done correctly.

Councilmember Escobar had the following questions:

- 1. Why was this not brought on September 10?
- 2. Can you confirm that the last time the seat was vacant it was between 45-60 days?
- 3. What do other cities do?
- 4. If this was brought before September 10, why was it not considered with the nomination period that closed on August 10?
- 5. Was she briefed on the CALPERS retirement plan?
- 6. What's the difference between 60 day delay and 14 day delay?
- 7. When was the last time the councilwoman worked?

MOTION BY COUNCILMEMBER ROBLEDO, SECOND BY COUNCILMEMBER ESCOBAR, CARRIED 4-2 (MAYOR SANDOVAL AND COUNCILMEMBER CARRIZOSA OPPOSED), continuing this item to the meeting of October 1, 2018 and directing the City Attorney to provide responses prior to the meeting to aforementioned questions.

# **PRESENTATIONS**

A. Presentation on the Federal Opportunity Zones Program

Deputy City Manager Pelser presented a report and answered questions from Councilmembers.

B. Approve a Proclamation of the City Council of the City of Pomona, County of Los Angeles, State of California, Declaring the Month of September 2018 as "Childhood Cancer Awareness Month"

MOTION BY COUNCILMEMBER CARRIZOSA, SECOND BY COUNCILMEMBER TORRES, CARRIED 6-0, approving the proclamation.

C. Approve and Present a Proclamation, Recognizing and Supporting the Goals of "Life Insurance Awareness Month" the month of September 2018 in the City of Pomona (Recipient-Christine Perez)

MOTION BY COUNCILMEMBER ROBLEDO, SECOND BY COUNCILMEMBER TORRES, CARRIED 6-0, approving the proclamation.

The Mayor and Council read and presented the proclamation to Christine Perez, New York Life Insurance Company. She thanked the Council and the City and spoke on the importance of life insurance.

# MAYOR/COUNCILMEMBER COMMUNICATIONS

Councilmember Torres thanked the police department for leading the Area Commander Neighborhood Watch meeting last week. He reported there were over 100 residents from Districts 1 and 6 present and that he had the opportunity to discuss the current financial state of the City and the crucial need for resident support of the ballot measures.

Councilmember Carrizosa thanked the Public Works and Administration departments, noting that Mission Avenue looked beautiful. She suggested maybe some trees and plants could make it look even better.

Councilmember Gonzalez recognized and thanked Pomona Unified School District (PUSD) colleagues Dr. Roberta Perlman and Dr. Frank Guzman. He thanked the police department for the Watch Commander community event at Kennedy Park, with a turnout of at least 70 residents. He discussed the PUSD student safety summit, noting that both events combined had put residents at ease regarding recent events, and reinforced the police department's hard work. He also thanked the police department for getting two sexual predators off the streets.

### **CITY MANAGER COMMUNICATIONS**

City Manager Lowry requested an additional adjournment to the meeting in memory of former City employee John Sidow.

MOTION BY COUNCILMEMBER ROBLEDO, SECOND BY COUNCILMEMBER CARRIZOSA, CARRIED 6-0, to adjourn the meeting in memory of John Sidow.

### **PUBLIC PARTICIPATION**

Douglas Pierce submitted a speaker card, but was not present when called to speak.

David Holmes, Pomona, thanked the Mayor and Council for their help with a pallet issue. He discussed a pallet yard on 3<sup>rd</sup> Street that had a fire recently and was still operating. He expressed concern that this was a safety issue for the employees there.

Holly Reynolds, Fairplex Executive Director of Learning Centers, reported that this was the 19<sup>th</sup> year they were able to offer free school field trips to the Fair. She noted they had a Route 66 theme with history and geography exhibits, and had a day for kids with special needs and sensory issues.

Deborah Clifford, Pomona, spoke on her family history of WWII war pilots and told a story about how Pomona was the only U.S. City bombed (accidentally) in WWII.

Randy Beckendam, Pomona, spoke on the Place Making meeting coming up at the Purpose Church. He spoke about the Pomona Unified Voices grant to build an Eco farm.

Elinor Crescenzi, Pomona, spoke on zero waste and urged Council to make a plan to be proactive. She said it was inappropriate for Council to curtail the public comment time limit.

Eunice Russell, Pomona, spoke on the 2018 Council Candidate Forums coming up. She announced that one would take place at Western University with the Willie White focus group, and that the Chamber of Commerce would also be holding a forum.

John Mendoza, Pomona, spoke on his support for zero waste and the need for a recycle ordinance. He also spoke on the F Zone and the need for a better update before it goes to the Planning Commission.

M. Joyce Bakersmith, Pomona, spoke on the Cultural Festival coming up at Willie White Park on October 20, 2018. She requested \$2600 from the Council and asked that the Cultural Festival be made a City event. She said this was the third year she has requested this funding by the City.

Councilmember Escobar made a statement regarding the seriousness of this matter. She thanked the Council for taking this matter seriously and Councilmember Carrizosa for her solidarity in this matter. She added that she hoped this action would set a precedent for decency. This led to brief discussion of the statement.

**9.** Consideration of Draft Ordinance Regulating Commercial Cannabis Businesses and Further Council Direction on Finalizing the Draft Ordinance and Related Policies

### ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE POMONA CITY CODE BY ADDING CHAPTER 74, "COMMERCIAL CANNABIS ACTIVITY," TO THE POMONA CITY CODE; AND AMENDING POMONA ZONING ORDINANCE NO. 1673 BY ADDING SECTION .58015, "CONDITIONAL USE PERMIT AND DEVELOPMENT AGREEMENT REQUIRED FOR COMMERCIAL CANNABIS ACTIVITY," TO ALLOW CLASSIFICATIONS OF COMMERCIAL CANNABIS ACTIVITY [IN ZONES] [OR IN PORTIONS OF ZONES] [OR TO ESTABLISH A SPECIAL OVERLAY ZONE] AND REPEAL PROVISIONS INCONSISTENT OR IN CONFLICT WITH THIS ORDINANCE

Judith St. John, Pomona, spoke in opposition to the ordinance. She said the City's reputation had already been tarnished and asked that if made legal, it be banned from Fairplex events.

Mark Ramos, UFCW Union Pomona, spoke in support of the ordinance and a merit based system to bring in businesses. He offered help from his union to craft a merit based system

that would work. He urged the Council to do this right and allow the workers of these businesses to have a Labor Peace Agreement.

Damian Martin spoke against having a lottery system for applicants, noting that there were many drawbacks.

Jonathan Cvetko, LA County Board of Supervisors Cannabis Advisory Work Group and Executive Director of Angeles Emeralds, spoke in support of the ordinance. He stated the Fairplex was a great opportunity and should be included. He recommended the merit based system include a selection committee should there be a tie and not a lottery system in order to ensure the Council maintains control of which businesses come in to the City. He recommended that applicants not be required to already have a property before they apply as that could delay the process and prevent quality applicants from being awarded a business.

Lilia Ornate, Partnership for Positive Pomona and Pomona's Youth Prevention Council, had several recommendations for the ordinance should it pass. These included distances from youth, caps on businesses, no advertising to youth and mandatory prevention education for workers. She offered the services of three prevention programs already in Pomona.

Councilmembers continued discussion related to the Cannabis Ordinance. New sensitive use maps were presented by the City Attorney's office to the Council and public. There was Council consensus on the classification categories of cannabis. Other discussion topics included the limits for the number of businesses, allowing festivals at the Fairplex, minimum application requirements and fees for applicants.

Councilmember Carrizosa left the meeting at 11:11 p.m. Prior to her leaving, the Mayor presented her with sympathy certificates for Oscar Cruz Carrizosa and Maritza Martinez.

# MATTERS INITIATED BY CITY COUNCILMEMBERS

Councilmember Gonzalez spoke about Senate Bill 946 regarding sidewalk vendors being signed by Governor Brown. He asked that staff working on the City ordinance ensure that the impacts of the governor signing the bill be addressed.

Mayor Sandoval reminded staff about the pallet business issue and wanted to ensure Code Enforcement was working on the issue.

# **ADJOURNMENT**

The City Council meeting was adjourned at 11:31 p.m. in memory of Oscar Cruz Carrizosa, Maritza Martinez and John Sidow.

The next regular City Council meeting will be held on Monday, October 1, 2018. Closed session will begin at 5:30 p.m. and the open session shall commence at 7:00 p.m. in the City Council Chambers.
