## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, ACCEPTING THE U.S. DEPARTMENT OF JUSTICE'S (DOJ) BULLETPROOF VEST PARTNERSHIP (BVP) GRANT IN THE AMOUNT OF \$25,334 AND AMENDING THE FY 2018-19 POLICE DEPARTMENT APPROPRIATIONS AND RESOURCES IN THE AMOUNT OF THE GRANT

**WHEREAS**, the U. S. Department of Justice (DOJ) has awarded the Pomona Police Department with a Bulletproof Vest Partnership (BVP) grant in the amount of \$25,334 to purchase new/replacement bulletproof vests for sworn personnel;

**WHEREAS**, the BVP grant is a 3-year program, allowing the Police Department to apply for years 2 and 3 non-competitively to seek additional funding for those bulletproof vests identified for replacement; and,

**WHEREAS,** the authority to accept DOJ's Bulletproof Vest Partnership (BVP) Grant and amend the FY 2018-19 special revenue operating and revenue budgets to appropriate the grant funds to be received is vested with the City Council.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**<u>SECTION 1</u>**. That the City Council hereby accepts the 2018 Department of Justice's (DOJ) Bulletproof Vest Partnership (BVP) Grant and agreeing to the terms and conditions of the Grant Agreement.

**SECTION 2.** That the City Council amends the FY 2018-19 Police Department expenditures (215-2090-52431-58704) and revenues (215-2090-40875-58704) for grant funds to receive and appropriate \$25,334.

**<u>SECTION 3.</u>** That the City Council approves a sole source purchase contract to Safariland, utilizing the Mallory Safety & Supply cooperative agreement, contract no. 4400008468.

**<u>SECTION 4.</u>** That the City Manager, or designee, is hereby authorized to execute any and all agreements on behalf of the City.

<u>SECTION 5</u>. The City Clerk shall attest to and certify to the passage and adoption of this resolution and it shall be effective immediately upon its approval.
