The petition entitled "AN INITIATIVE MEASURE TO ENACT A THREE-QUARTER PERCENT (0.75%) INCREASE IN THE CITY'S UTILITY USERS TAX FOR A PERIOD OF TEN YEARS UNLESS EXTENDED BY THE CITY COUNCIL, AND ESTABLISH AN EXEMPTION OF THE USER UTILITY TAX FOR LEGALLY HANDICAPPED RESIDENTIAL RATE PAYERS" was filed with the City Clerk's Office on August 28, 2018.

That the affiant stated his or her own qualification, that he or she had solicited the signatures upon that Section, that all of the signatures were made in his or her presence, and that to the best of his or her own information and belief, each signature to that section was the genuine signature of the person whose name it purports to be;

That after the proponents filed this petition and based on the County of Los Angeles Registrar of Voters' Signature Verification system, and the Elections Official (City Clerk) application of the random sampling for verification of signatures formula, I have determined the following facts regarding this petition:
