

**RESOLUTION NO. 2018-**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2018-19 PUBLIC WORKS OPERATING BUDGET BY RE-APPROPRIATING \$92,700 TO THE TRANSPORTATION FUNDS 208-250-52425-00000, 138-2520-52425-00000, 206-2520-52425-00000 FOR THE CONVERSION OF ONE OF THE CITY'S HEAVY DUTY TRUCKS INTO AN ASPHALT MATERIAL PATCH TRUCK WHICH WAS PREVIOUSLY AUTHORIZED IN FISCAL YEAR 2017-18**

**WHEREAS**, in Fiscal Year 2017-18, the City Council approved a contract with PB Loader for the conversion of one of the City's existing heavy duty trucks into an Asphalt Material Patch Truck;

**WHEREAS**, the City did not receive delivery of the converted Asphalt Material Patch Truck by June 30, 2018 resulting in the need for funding in Fiscal Year 2018-19;

**WHEREAS**, as allowed by the City's Charter, the recommended actions will amend FY 2018-19 Operating Budget by authorizing the carryover and re-appropriation of funding for the truck conversion approved for purchase during FY 2017-18 in the amount of \$92,700.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** Amend the FY 2018-19 Public Works Operating Budget by re-appropriating \$92,700 of available Transportation Funds as depicted below:
