

**RESOLUTION NO. 2018-**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2018-19 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET TO CREATE A NEW CIP PROJECT, “MEDIAN IMPROVEMENTS – TOWNE AVENUE AND MCKINLEY AVENUE,” PROJECT NO. 428-2590-XXXXX-67926, AND APPROPRIATING \$20,000 FROM DISTRICT 4 DISCRETIONARY FUND BALANCE**

**WHEREAS**, the City Council wishes to amend the FY 2018-19 CIP Budget by creating a new CIP project, “Median Improvements – Towne Avenue and McKinley Avenue,” Project No. 428-2590-xxxxx-67926;

**WHEREAS**, the City Council desires to appropriate \$20,000 from District 4 Discretionary Fund balance (418-1302-89987-72104) to “Median Improvements – Towne Avenue and McKinley Avenue,” Project No. 428-2590-xxxxx-67926; and

**WHEREAS**, the proposed median improvement project consists of constructing a new median connecting two existing medians at the intersection of Towne Avenue and McKinley Avenue to prevent vehicles from making unsafe turning movements.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** The City Council amends the FY 2018-19 CIP Budget by:

- a. Creating a new CIP project, “Median Improvements – Towne Avenue and McKinley Avenue,” Project No. 428-2590-xxxxx-67926; and
- b. Appropriating \$20,000 from District 4 Discretionary Fund balance (418-1302-89987-72104) to “Median Improvements – Towne Avenue and McKinley Avenue,” Project No. 428-2590-xxxxx-67926.

**SECTION 2.** The City Clerk shall attest and certify to the passage and adoption of this Resolution and it shall become effective immediately upon its approval.
