

RESOLUTION NO. 2019-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, FOR THE MODIFICATION OF A PREFERENTIAL PARKING DISTRICT IN THE AREA OF EAST PASADENA STREET AND SAN FRANCISCO AVENUE BETWEEN TOWNE AVENUE AND SAN ANTONIO AVENUE

WHEREAS, non-resident and an oversaturation of residential parking on City streets located on East Pasadena Street and San Francisco Avenue, bordered by Towne Avenue and San Antonio Avenue ("Preferential Parking District") was causing extreme hardship among the residents of Pomona and negatively impacting their quality of life; and

WHEREAS, on May 21, 2018, pursuant to City Code Section 58-239, the City Council established a Preferential Parking District addressing resident concerns, and also addressed the City's health and safety concerns regarding the accumulation of trash and debris and the potential for accumulated debris to enter the City's storm water system; and

WHEREAS, the Preferential Parking District limits each household/unit to a maximum of one (1) guest permit and prohibits overnight parking on the designated streets from 6:00 p.m. to 6:00 a.m. without said permit; and

WHEREAS, residents within the Preferential Parking District, aggrieved by the City Council's decision to establish said District, first notified the City of their appeal on June 13, 2018 pursuant to City Code Section 58-239(g) and subsequently provided signed petitions to remove the District; and

WHEREAS, at the October 15, 2018 City Council meeting a Public Hearing was held to reconsider the District and at the meeting a determination was made to set a Community Meeting to allow for additional input and understanding among different residents; and

WHEREAS, at a community meeting held on November 13, 2018, along with hearing arguments for either upholding or terminating the Preferential Parking District, a suggestion was made to modify the Preferential Parking District by issuing a total of two permits per household/unit and reducing the restricted parking time from 6:00 p.m. - 6:00 a.m. to 10:00 p.m. - 6:00 a.m.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council hereby modifies the Preferential Parking District, consisting of City streets located on East Pasadena Street and San Francisco Avenue, bordered by Towne Avenue and San Antonio Avenue, as shown in Exhibit A, which is attached hereto and incorporated by reference.

SECTION 2. The modification consists of issuing a total of two permits per household/unit and reducing the restricted parking time from 6:00 p.m. - 6:00 a.m. to 10:00 p.m. - 6:00 a.m.

SECTION 3. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
