A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA MAKING A FINDING OF GENERAL PLAN CONFORMITY FOR THE PROPOSED AMENDMENT OF THE POMONA CITY CODE (SECTION 58-294) PERTAINING TO TRUCK ROUTE DESIGNATIONS

THE CITY COUNCIL OF THE CITY OF POMONA DOES RESOLVE AS FOLLOWS:

WHEREAS, the applicant, the City of Pomona, is requesting General Plan Conformity for the proposed amendment of the Pomona City Code (Section 58-294) pertaining to truck route designations; and

WHEREAS, the proposed amendment to truck route designations is consistent with the City's General Mobility and Access Element;

NOW, THEREFORE, BE IT HEREBY RESOLVED by the City Council of the City of Pomona, California:

SECTION 1. The City Council exercising their independent judgment has determined that pursuant to the California Code of Regulations, Title 14, Guidelines for the Implementation of the California Environmental Quality Act (CEQA), Class 1 Section 15301(c), adoption of a citywide truck route ordinance to amend existing sections with specified streets is categorically exempt from CEQA because the truck routes make use of the existing roadways currently used by trucks. No new segments of roads have been identified for truck routes that are not currently used by trucks. As a result, the adoption of the recommended truck routes would not change the distribution of truck traffic compared to existing conditions.

SECTION 2. In any part, provision, or section of this resolution is determined by a court or other legal authority with jurisdiction over the subject matter of this resolution to be unenforceable or invalid, the remainder of the entirety of this resolution shall not be affected and shall continue in full force and effect. To this end, the provisions of this resolution are severable.

SECTION 3. In support of the General Plan Conformity finding, the City Council hereby finds and determines as follows:

The proposed amendment of the Pomona City Code (Section 58-2914) pertaining to designated truck routes is consistent with the Mobility and Access of the General Plan, specifically:

Policy 7D.P14: "Consider re-classifying designated truck routes to minimize impacts on residential neighborhoods from truck movement and overnight parking."

Goal 7D.G1: "Distribute vehicular, transit, bicycle, and pedestrian traffic appropriately throughout the City."

Goal 7D.G3: "Monitor congestion of the five (5) freeways serving Pomona and control spillover traffic from freeways onto City streets."
