### MAYOR/COUNCILMEMBER COMMUNICATIONS

Councilmember Escobar reported that she had attended several Easter Egg Hunt events in the City, and had represented the City of Pomona at the Federal Bureau of Investigation and Homeland Security and Border Patrol conference in Long Beach.

Councilmember Robledo announced that the District 2 Community Clean Up would take place on Saturday, April 7, 2018, at 7:00 a.m. at Behar Elementary School, and urged everyone to participate.

Councilmember Carrizosa thanked the Community Services and Public Works Departments for the work they had done for the Easter Egg Hunt activities. She noted that she had attended the Coffee with a Cop event and the Cesar Chavez Annual Breakfast. She commented on the Compassionate Values proclamation and noted that a well-known humanitarian had said that Pomona was a "city with a heart."

Mayor Sandoval stated that the City of Pomona had a history of compassionate and caring service, noting the many hospitals and care facilities in the city.

Councilmember Gonzalez reported that he had attended the following events: Cesar Chavez

Breakfast, various Easter Egg Hunts, the funeral for Officer Greggory Casillas, a reading event at the dA Center for the Arts, the opening ceremony for the Pomona American Little League, the Pomona Unified School District Robotics Competition, and welcomed Dolores Huerta at an event at the University of LaVerne.

Vice Mayor Torres thanked the Police Department for the work they had done to organize a Neighborhood Watch group on the north side of District 6. He noted that the residents were excited to partner with the Police Department and the City to improve their neighborhood. He announced that the District 6 Community Clean Up would take place on April 21, 2018, at Palomares Park.

Councilmember Ontiveros-Cole thanked everyone that had participated in the memorial services for Officer Greggory Casillas. She advised that she had organized a meeting with leaders from the Pomona Unified School District, the Police Department, and the City Manager to address the problems that had been taking place at Montview Elementary School. She announced that the District 4 Community Clean Up would take place on April 14, 2018, at the Calvary Chapel on the corner of San Bernardino Avenue and San Antonio Avenue.

Mayor Sandoval thanked staff for the work that they had done for the various Easter Egg Hunts throughout the City. He thanked "Bull Dog" Jessie and all of those that had organized the Vietnam Veterans event at Veterans Park.

#### **CITY MANAGER COMMUNICATIONS**

City Manager Lowry stated that she had nothing to report.

## **PUBLIC PARTICIPATION**

Douglas C. Pierce, Pomona resident, read the Fourth Amendment and commented on property he owned in the city.

Don Martins, Pomona resident, thanked the City Council for the Compassionate Values proclamation, and noted that there was much work to be done to implement those ideals.

Jesus Campos and Wesley Campos, Pomona residents, noted that there were a number of displaced farm workers in the city, and submitted a letter to the City Clerk regarding the issue. They stated that they were in favor of Item No. 4.

John Mendoza, Pomona resident, thanked the Latino Roundtable for sponsoring the Cesar Chavez Breakfast. He commented on the role that Pomona plays in the health care industry in the San Gabriel Valley, the Fairplex Strategic Plan, and inquired as to the status of the F Zone. He urged support for the water bond that would be on the November ballot.

Roberta Arnold, Pomona resident, noted that there were no services in Pomona for veterans, and urged the City Council to help provide services for veterans.

Mr. Hernandez commented on a number of Pomona Valley Hospital employees that had been City of Pomona Page 5

retaliated against for advocating better patient care at the last City Council meeting.

Randy Beckendam, Pomona resident, introduced April Barker, Adult Transition Program teacher, who provided a report on their school garden, and read testimonials from her students regarding their experiences working in the garden. She noted that the garden had been entered in a school garden contest.

Deborah Clifford, Pomona Valley Historical Society representative, provided the April History notes, and informed that on Christmas Eve 1899, there was a train wreck just outside of the city, and that the residents went out and provided care for those in the wreck, taking many of them into their homes. She noted that as a result of that event, the City leaders determined that Pomona needed a hospital, which led to the founding of the Pomona Valley Hospital. She also reported on the Whipp family of Pomona and the contributions they had made to the city.

Carlos Gonzalez, Pomona resident, requested assistance with a situation that was taking place behind his home with a number of homeless individuals. He noted that he had installed cameras on his home, and that homeless individuals had been in his yard, and there was illegal drug use, fighting, and vandalism in the area behind his home.

Ms. Carpio, Pomona resident, expressed concern with a television report that indicated Pomona was in negotiations with Orange County to take displaced homeless individuals into the City. City Manager Lowry stated that the City was in negotiations with Los Angeles County for tax dollars for the Homeless Services Center; however, that there were no negotiations going on with Orange County.

Councilmember Carrizosa stated that there may be other organizations within the City in negotiations with Orange County, and requested that an official statement be issued confirming that the City of Pomona was not in negotiations with Orange County regarding the homeless issue.

Cielo Castro, Fairplex representative, reported that they had hosted the Pentathlon World Cup on March 28-30, 2018, showcasing Fairplex as a potential Olympic sports level venue. She invited everyone to the free family event, "Spring on the Farm," April 8, 2018, from 9:00 a.m. to 3:00 p.m. She noted that Fairplex was partnering with the Cyclavia event on April 22, 2018, at Palomares Park. She advised that the Fairplex Strategic Plan would be unveiled on April 12, 2018 at 10:00 a.m. at the Sheraton Fairplex, and that the public was invited.

Eunice Russell, Pomona resident, requested information on the City Plan update, grants, Phillips Ranch funding from the former Redevelopment Agency, the number of crime prevention officers, and when the District 6 Neighborhood Watch Program would be implemented.

Elinor Crescenzi, Pomona resident, requested that additional time be allotted for those speakers requiring translation services.

M. Joyce Bakersmith, Pomona resident, invited everyone to the Pomona Optimists Club fundraiser on April 12, 2018 from 5:00 to 10:00 p.m. at the Eagles Lodge. She noted that City of Pomona

tickets were \$20, and information could be obtained on the Pomona Optimists Club website.

Councilmember Carrizosa expressed concern with the retaliation issue which had been brought up by one of the speakers, and Mayor Sandoval noted that he would be speaking with officials from the hospital regarding the issue.

Oliver Unaka, Pomona Unified School District (PUSD) Public Information Officer, advised that the "Success Starts Here" Banner Campaign was designed to promote the success stories of the students from PUSD, and that each light pole would display two banners, one of the high school from which the student had just graduated, and one of the school/college/university which the student would be attending.

Mayor Sandoval expressed support for the program, and requested that those entering the military also be included in the program.

Councilmember Escobar requested that banners for Anti-Bullying week and Red Ribbon Week be included in the program.

Vice Mayor Torres expressed support for including those entering the military in the program. He requested that the City Council look at paying for banners to honor veterans.

Deputy City Manager Pelser informed that because direction was provided in Closed Session, he was not at liberty to disclose the negotiations; however, he noted that he had been in close communications with the Property Group, and that he had made them aware that this item was on the agenda.

Mayor Sandoval stated that he had tremendous respect for Mr. John Pena and the work that he had done in the downtown; however, he could not support approval of the item.

MOTION BY COUNCILMEMBER ESCOBAR, SECOND BY COUNCILMEMBER ONTIVEROS-COLE, CARRIED 7-0, to remove "Kennedy Park" from Item 4E, and replace it with "City Parks," and remove the requested amount of \$793.22, and replace it with "Amount requested: TBD."

Support Kids in Progress representative thanked Mayor Sandoval for his support for the Vietnam Veterans Event. She provided a brief video regarding the event.

"Bull Dog" Jessie, Pomona resident, noted the veterans that had attended the event were very touched, and he urged the City Council to provide a place for homeless veterans to sleep. He requested assistance with the expenses for the event.

MOTION BY COUNCILMEMBER ROBLEDO, SECOND BY COUNCILMEMBER ONTIVEROS-COLE, CARRIED 7-0, approving Item No. 4 Finding of Public Benefit to the Community at Large.

#### MATTERS INITIATED BY CITY COUNCILMEMBERS

Councilmember Escobar requested an update on the progress of the Marijuana ordinance from the City Attorney. She also requested a list of the beautification projects scheduled for the Pomona Beautification Day. She asked to schedule an event at Phillips Park to hand out the Doggie Waste Key Chains that Mayor Sandoval had funded.

Councilmember Carrizosa requested an update regarding the Veterans Housing project at Park Avenue and Commercial Street. She asked for a list of the fire hydrants that still needed painting in District 3.

Vice Mayor Torres inquired as to the deadline for adding projects to the Beautification Day

project list, requested a status update on the vacant property at LaVerne Avenue and Garey Avenue, and noted that there were parking issues on Falcon Street bordering the City of LaVerne.

Councilmember Gonzalez expressed concern with the report regarding the Orange County homeless situation, and requested that staff stay abreast of the issue.

Councilmember Ontiveros-Cole inquired and City Manager Lowry informed that as much as staff would like to paint the curbs red in front of all fire hydrants, there was a limited capacity to maintain the curbs, and that resources only allowed for maintenance on the main arterials in the City.

The City Council meeting was adjourned at 8:59 p.m. (The meeting was adjourned back into Closes Session.)
