# RESOLUTION NO. 2019-18 – A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING THE ACCEPTANCE OF AN ADDITIONAL \$400,000 IN MEASURE H CAPITAL COST FUNDS AND AMENDING THE FY 2018-19 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY APPROPRIATING \$400,000 IN MEASURE H CAPITAL COST FUNDS TO "YEAR-ROUND EMERGENCY SHELTER," PROJECT NUMBER 428-2590-XXXXX-71044

**WHEREAS**, on November 21, 2016, the City Council authorized the purchase 1400 East Mission Boulevard, APN's 8327-014-028 and 8327-014-029, for development of a homeless emergency shelter and services center site and approved creation of a "Year-Round Emergency Shelter," CIP Project No. 428-2590-XXXXX-71044 within the Capital Improvement Program; and,

**WHEREAS**, on November 6, 2017, the City Council awarded a contract to TELACU Construction Management in the amount of \$3,890,017 to construct the "Essential Service Area" of the Year-Round Emergency Shelter and approved, as to concept, the future development of the "Additional Service Areas", should funding become available; and,

**WHEREAS**, on July 2, 2018, the City Council accepted an award of \$3,400,000 in Measure H Capital Cost for Crisis and Bridge Housing Funds for the development of Phase 2 of the Year-Round Emergency Shelter, amending CIP Project Number 428-2590-XXXXX-71044 Budget by the same amount.

**WHEREAS**, on August 6, 2018, the City Council amended the contract with TELACU Construction Management for Design-Build Services for Additional Service Areas at the "Year-Round Emergency Shelter," Project No. 428-2590-XXXXX-71044; and,

**WHEREAS**, it has been determined that the City is able to utilize additional Measure H Funds for the development of the year-round emergency shelter; and,

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1**. Adopt a resolution authorizing the acceptance of an additional \$400,000 in Measure H Capital Costs Funds for the development of the Additional Services Area of the "Year-Round Emergency Shelter" and amending the FY-2018-19 Capital Improvement Budget (CIP) by appropriating this award of \$400,000 in Measure H Capital Cost funds to "Year-Round Emergency Shelter," Project Number 428-2590-XXXXX-71044.

**<u>SECTION 2</u>**. Authorize the City Manager to hereby execute all documents related to this action.

**<u>SECTION 3</u>**. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
