

**RESOLUTION NO. 2019-XX**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA,  
CALIFORNIA, APPROVING A NEW CALTRANS FREEWAY  
AGREEMENT FOR STATE HIGHWAY ROUTE 71**

**WHEREAS**, the City of Pomona (City) previously executed Freeway Agreements with the State of California Department of Transportation (Caltrans or State) dated June 6, 1966; June 5, 1972; February 23, 1987; June 1, 1992 and October 15, 2012;

**WHEREAS**, the City seeks to allow the State to complete design and construction of the SR-71 Highway to Freeway Gap Conversion project (Project) to include: widening of SR-71 from I-10 to SR-60, a new pedestrian bridge to replace the Grier Street bridge, street closures (eliminating connections between SR-71 at Phillips Dr., North Ranch Rd., and Old Pomona Rd.), other City streets re-configurations as shown on Exhibit A to the Freeway Agreement, no new frontage roads (between Phillips and North Ranch Roads), and no new vehicular crossing bridge of SR-71;

**WHEREAS**, the City acknowledges that a new Freeway Agreement is needed for SR-71 to supersede prior Freeway Agreements and reset the framework for the Project to continue to move forward;

**WHEREAS**, the City acknowledges that a new Freeway Agreement is needed for SR-71 to allow for additional separate agreements that may be needed for funding, construction, right-of-way, and similar other matters;

**WHEREAS**, the City acknowledges that a new Freeway Agreement is also needed for SR-71 to addresses City acceptance of modified City streets for control and maintenance;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** The City Council approves the Freeway Agreement for 07-LA-71 R0.5/R4.7, in Pomona, from 0.1 mile South of Route 10 to 0.4 mile South of Route 60 (Agreement).

**SECTION 2.** The City Council authorizes the Mayor to execute the aforementioned Agreement and any necessary documents and modifications related thereto.

**SECTION 3.** The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
