

**RESOLUTION NO. 2019-32**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA AMENDING APPENDIX B OF THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF POMONA AND THE POMONA CITY EMPLOYEES' CHAPTER OF THE TEAMSTERS LOCAL 1932 BY DELETING THE CLASSIFICATION OF PUBLIC SERVICES SPECIALIST AND ADDING THE CLASSIFICATION OF LEAD LANDSCAPE MAINTENANCE TECHNICIAN**

**WHEREAS**, the City Council has the authority to create, classify and assign salary scales/ranges for Pomona City Employees' Association positions for the City of Pomona;

**WHEREAS**, on April 23, 2018, the City Council adopted Resolution No. 2018-34 adopting the 2017-2019 Memorandum of Understanding (MOU) between the City of Pomona and the Pomona City Employees' Chapter of the Teamsters Local 1932 (PCEA), which also established a Roster of PCEA General Service Classifications

**WHEREAS**, the City Council has subsequently amended certain provisions of the MOU by resolution number 2018-72; and

**WHEREAS**, the City Council desires to amend Appendix B of the aforementioned MOU by the actions provided herein.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona, California, as follows:

**SECTION 1.** That the City Council hereby amends Appendix B of the PCEA MOU by deleting the Public Services Specialist classification and creating the Lead Landscape Maintenance Technician classifications as follows:
