

**RESOLUTION NO. 2019-33**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA AMENDING APPENDIX B OF THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF POMONA AND THE POMONA MID-MANAGEMENT / CONFIDENTIAL EMPLOYEES' ASSOCIATION TO DELETE THE CLASSIFICATION OF CODE COMPLIANCE MANAGER AND ADD THE CLASSIFICATION OF CODE COMPLIANCE SUPERVISOR**

**WHEREAS**, the City Council has the authority to create, classify and assign salary scales/ranges for all City of Pomona classifications;

**WHEREAS**, the City Council has the authority to amend the staffing allocations;

**WHEREAS**, on May 7, 2018 the City Council adopted Resolution No. 2018-47 adopting the extension and amendment of the 2016-2017 Memorandum of Understanding (MOU) between the City of Pomona and the Pomona Mid-Management/Confidential Employees' Association (PMMCEA), which also established a Roster of PMMCEA Classifications;

**WHEREAS**, the City Council has subsequently amended certain provisions of the MOU by resolution numbers 2018-73 and 2018-160; and

**WHEREAS**, in order to meet department staffing needs, the City Council desires to amend Appendix B of the aforementioned MOU by the actions provided herein.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Pomona as follows:

**SECTION 1.** That the City Council hereby authorizes changes to be made to Appendix B of the PMMCEA MOU by deleting the classification of Code Compliance Manager and adding the classification of Code Compliance Supervisor as shown below.
