

**RESOLUTION NO. 2019-34****A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA AMENDING THE COMPENSATION PLAN FOR EXECUTIVE MANAGEMENT GROUP A AND B EMPLOYEES BY INCREASING THE SALARY RANGES FOR THE CLASSIFICATIONS OF PUBLIC WORKS DIRECTOR AND WATER RESOURCES DIRECTOR**

**WHEREAS**, the City Council has the authority to create, classify and assign salary scales/ranges to the Compensation Plan for Executive Management Group A and B Employees (A-B Plan) of the City of Pomona;

**WHEREAS**, on September 17, 2018, the City Council adopted Resolution No. 2018-136 amending the A-B Plan; and

**WHEREAS**, the City Council desires to amend Appendix A of the aforementioned A-B Plan by adjusting the salary for Public Works Director and Water Resources Director as provided herein.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona, California, as follows:

**SECTION 1.** That the City Council hereby authorizes changes to be made to Appendix A of the A-B Rules' by modifying the salaries below:
