## **RESOLUTION NO. 2019-31**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, APPROVING A COOPERATIVE AGREEMENT WITH THE COUNTY OF LOS ANGELES FOR STREET REHABILITATION-DISTRICT 6, PROJECT NO. 428-2590-XXXXXX-67921 AND AMENDING THE 2018-19 CIP BUDGET BY APPROPRIATING A \$311,480 CONTRIBUTION TO THE PROJECT FROM THE COUNTY OF LOS ANGELES

- **WHEREAS**, the City of Pomona strives to promote improved streets for all its community members and visitors, and has been upgrading arterials leading into and through the City through the Capital Improvement Program (CIP);
- **WHEREAS**, Towne Avenue, from Foothill Boulevard to Bonita Avenue, is a principal arterial for the community, developments, and surrounding area, including the City of Claremont and Los Angeles County;
- **WHEREAS**, Street Rehabilitation District 6, Project No. 428-2590-XXXXX-69721 is a project in the CIP;
- **WHEREAS**, an approximate 640 foot length of Towne Avenue, between 180 feet south of Richbrook Street and East Grove Street, is technically under the jurisdiction of the County of Los Angeles;
- **WHEREAS**, **WHEREAS**, Towne Avenue, from Foothill Boulevard to 180 feet south of Richbrook Street, and the southbound and portion of northbound lanes from East Grove Street to Harrison Avenue, are under the jurisdiction of the City of Pomona for street purposes;
- **WHEREAS**, the City Public Works Department has arranged for funding from Los Angeles County in the amount of \$311,480 for improvement of the length of Towne Avenue under the jurisdiction of the County as part of the attached Exhibit A Cooperative Agreement; and
- **WHEREAS**, upon completing execution of the attached Cooperative Agreement, a \$311,480 contribution from Los Angeles County may be received by the City and appropriated to Street Rehabilitation District 6, Project No. 428-2590-XXXXX-69721
- **NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:
- **SECTION 1.** The City Council hereby approves a Cooperative Agreement, attached as Exhibit A, with the County of Los Angeles to administer a contribution of \$311,480 from Los Angeles County for Towne Avenue.

**SECTION 2.** The City Council hereby finds that the "Street Rehabilitation - District 6," Project No. 428-2590-XXXXX-67921 is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15301(c), in that the project consists of the operation, repair and maintenance of existing streets

**SECTION 3.** The City Council hereby authorizes the City Manager and/or Mayor to take all necessary actions needed by Los Angeles County and others to execute the Cooperative Agreement and related project funding documents on behalf of the City for Street Rehabilitation – District 6, Project No. 428-2590-XXXXXX-69721.

**SECTION 4.** The City Council amends the FY 2018-19 Budget and hereby receives and appropriates a \$311,480 contribution from Los Angeles County to Street Rehabilitation – District 6, Project No. 428-2590-XXXXX-69721.

**SECTION 5.** That the City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
