A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2018-19 CITY OPERATING BUDGET, BY DECREASING REVENUE ESTIMATES AND APPROPRIATIONS FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM BY \$186,159 AND INCREASING APPROPRIATIONS FOR THE LOW-MOD HOUSING ASSET FUND BY \$29,887

WHEREAS, it is the desire of the City Council to amend the FY 2018-2019 Adopted Operating Budget for appropriation and un-appropriation of various grant funds;

WHEREAS, the Pomona City Charter requires that amendments to the Adopted Annual Operating Budget be approved by City Council by Resolution;

WHEREAS, it has been determined that the City is able to utilize the non-federal, Low-Moderated Income Housing funds for eligible expenses; and

WHEREAS, the City Council must find that under the Federal guidelines established by the U.S. Department of Housing and Urban Development, the proposed changes are eligible uses of CDBG funds and will serve low- to moderate-income persons and/or areas.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

<u>SECTION 1</u>. That on April 1, 2019, the City Council approved the proposed amendments to the Fiscal Year 2018-2019 City Operating Budget decreasing \$186,569 in revenue estimates and appropriations for the Community Development Block Grant (CDBG) Program and increasing appropriations for the non-federal, Low-Mod Housing Asset Fund by \$29,887.

<u>SECTION 2</u>. The adopted FY 2018-2019 City operating budget is hereby amended to reflect changes to revenue estimates and appropriations/un-appropriations, as follows:
