MAYOR/COUNCILMEMBER COMMUNICATIONS

In accordance with AB1234, the Mayor and Councilmembers reported on the following:

Councilmember Carrizosa thanked the volunteers that had participated in the Red Cross smoke detector program.

Councilmember Escobar reported that she had graduated from the inaugural class of the Water Education for Latino Leaders (WELL) in Sacramento on February 28, 2018. She commented on the Red Cross smoke detector program, and announced the St. Puppy's Day Extravaganza on March 17, 2018 at Phillip's Paw Park.

Councilmember Gonzales reported that he had participated in the Read Across America program for the Pomona United School District.

Mayor Sandoval congratulated Hilda Fulkner on her 108th birthday. He reported that he had the opportunity to participate in the Read Across America program, and thanked the Heart Team for their work to help clean-up the area around Holt Avenue and Reservoir Street.

CITY MANAGER COMMUNICATIONS

City Manager Lowry did not have anything to report.

The proclamation was presented to members of Day One Pomona.

PUBLIC PARTICIPATION

Douglas Pierce, Pomona, commented on street people, and trash along the railroad tracks on Fourth Street and Reservoir Street.

Daniel Lovanos, One Legacy ambassador, spoke regarding organ donations, and requested that the City Council proclaim April as DMV Donate Life month.

Rosie Hernandez, Claremont, expressed concern with the impact of a proposed three-story hotel on Foothill Boulevard and the community bordering Pomona and Claremont.

Deborah Clifford, Pomona Historical Society, provided the Monthly Pomona History report and spoke about Jose Antonio Perez and his impact on Pomona.

Andrea Yvette Lee, Pomona, spoke regarding the command to love God and love your neighbor.

Holly Reynolds, Fairplex representative, reported on various activities and events taking place at Fairplex, and announced the new Fairplex app.

Eric Moreno, Pomona, expressed concern with the condition of the community, the youth, and abandoned buildings.

James Galivan, Pomona, expressed concern with the streetscape change in front of the Fire House Inn, and the need to preserve Pomona's historical sites.

Felice Loverso, Casa Colina Hospital, expressed concern with the proposed ordinance regarding minimum wage for hospital workers, and mandates for infectious diseases at the hospital.

Elinor Crescenzi, Pomona, requested that the public be able to comment on Presentations, and the need for open dialog between the public and the City Council.

Randy Beckendam, Pomona, commended the City staff on the Zero Waste presentation that was made at the previous City Council meeting, and provided ideas for weed abatement on vacant lots.

Ms. Meza, Pomona, expressed concern with the living conditions at the apartments located in the city, and requested assistance from the city to mediate with the landlord. She noted that many residents had been served with eviction notices after reporting the conditions to Code Enforcement. The following individuals were also in support of the request, but did not wish to speak: Jose Diaz, Nicholas Predo, Ernestina Mendoza, Mr.Ybarra, Rita Serano, Miguel Flores, Alberto Andradi, and Cesar Ybarra.

Public Works Director McWade provided a brief history of the stable, and the options for use of the funds.

Deborah Clifford, Historical Society of Pomona Valley, spoke regarding the loss of the historic building, and offered her services to help the Historic Preservation Commission, the Parks and Recreation Commission, and staff to prioritize other historical sites for funding.

Discussion ensued regarding moving the stable to the Phillips Mansion site or somewhere in the downtown area, and to receive recommendations from the Historic Preservation Commission and the Parks and Recreation Commission. Direction was provided to staff to obtain two estimates from Ray Adamick, one for a careful demolition of the building by salvaging the brick and creating an inventory for future use; and one to rebuild the stable on another site.

MOTION BY MAYOR SANDOVAL, SECOND BY COUNCILMEMBER CARRIZOSA, CARRIED 7-0, to adopt Resolution No. 2018-16.

Chief Tony Cerda, Costanoan Rumsen Carmel Tribe, thanked the City Council for their past support of the event, and requested support for the upcoming event.

MOTION BY MAYOR SANDOVAL, SECOND BY COUNCILMEMBER CARRIZOSA, CARRIED 7-0, to approve the Find of Public Benefit to the Community at Large, Items A-D.

Development Services Director Suarez provided a brief report.

Mike Sater, owner, provided a brief history of his family's involvement in the community, their understanding of their responsibilities, and urged the City Council to approve the request.

Eric Lavon, Vice President of Sater Oil, noted that they are a commercial franchise operation, and are highly regulated by Arco BP and by the California Alcohol and Beverage Control department. He stated that they are committed to operating a top notch business, and requested that the City Council approve the PCN.

Elinor Crescenzi, Pomona, expressed concern with the way the high crime statistics were determined and high alcohol license density. She also noted the difficulty in accessing documents on the City's website.

Arturo Jimenez, Pomona, requested that staff and the City Council look at a different format for determining the density of alcohol licenses in the City considering the amount of high crimes in the areas around the various store locations. He stated that people did not feel safe shopping in Pomona.

Amos Young and Dan submitted speaker cards in support of the item; however, they did not wish to speak.

Councilmember Escobar, Councilmember Gonzales, and Vice Mayor Torres expressed support for approval of the PCN.

Councilmember Robledo stated that she was confident with the safety measures that were in place at the location.

Mayor Sandoval inquired and Mr. Lavon informed that all cashiers and clerks underwent the ABC Clerk Affidavit training, and the training was reemphasized every quarter. Mr. Lavon noted any sale of beer or wine required the scanning of the purchasers ID card, and that if they were not in the system, the sale was cancelled. He advised there were over 40 security cameras at the location to monitor all activity at the site.

Mayor Sandoval asked and Police Chief Oliveri advised that there were more crimes in that area due to the number retail businesses and shoplifting issues; however, it was considered to be a safe area.

Mayor Sandoval recognized the concerns of the community regarding the concentration of liquor licenses, and asked that staff bring back information regarding a joint task force to look at ways to minimize alcohol use by minors.

Councilmember Carrizosa agreed with Mayor Sandoval's request, and expressed the need to consider the overall impact on the area, not just the small area around the location.

MOTION BY COUNCILMEMBER ESCOBAR, SECOND BY COUNCILMEMBER ROBLEDO, CARRIED 6-1-0-0 (COUNCILMEMBER CARRIZOSA OPPOSED), to adopted Resolution No. 2018-18.

MOTION BY COUNCILMEMBER ESCOBAR, SECOND BY COUNCILMEMBER ROBLEDO, CARRIED 6-0-1-0 (MAYOR SANDOVAL ABSENT), to approved Resolution No. 2018-20.

MATTERS INITIATED BY CITY COUNCILMEMBERS

Councilmember Escobar requested that staff bring back a draft ordinance regarding medical marijuana and adult use marijuana within thirty days. She also requested that information be provided in the Thursday letter in order for the City Council to begin educating themselves on the matter.

Councilmember Ontiveros-Cole requested that staff bring back a report on the establishment of a Preferential Park District for the area of San Francisco Avenue and East Pasadena Avenue between Towne Avenue and San Antonio Avenue, as soon as possible.

Councilmember Robledo supported Mayor Sandoval's earlier requested regarding the formation of a task force to minimize the use of alcohol by minors. She requested a short presentation at the beginning of the next City Council meeting on the use of the City's website and how to access City Council agendas and staff reports.

Councilmember Gonzales announced that the Lighting Ceremony for the new lights at Kennedy Park would take place on Friday, March 9, 2018 at 6:00 p.m., and that opening day for the Pomona United Baseball Pony League would take place on Saturday, March 10, 2018 at 10:00 a.m.

Councilmember Carrizosa inquired and City Manager Lowry informed that staff was trying to work with the railroad to obtain permission to enter their property on Fourth Street and Reservoir Street in order to clean up the accumulated trash, and for the railroad to pay for the City of Pomona Page 9

cleanup.

Councilmember Ontiveros-Cole reported an increase of graffiti in the area of Alvarado Street and Towne Avenue, and requested that staff look into the matter.

Mayor Sandoval requested, and there was consensus by the City Council, to hold a Study Session on Monday, March 12, 2018, at 6:00 p.m. in order to receive as much information as possible regarding the proposed ordinance regarding the SCIU UHW ballot initiative involving Pomona Valley Hospital Medical Center and Casa Colina Hospital.
