### **RESOLUTION NO. 2019-40**

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, ADOPTING THE FY 2019-2020 ANNUAL ACTION PLAN WITH FUNDING RECOMMENDATIONS FOR COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG), HOME INVESTMENT PARTNERSHIPS (HOME) AND EMERGENCY SOLUTIONS GRANT (ESG) PROGRAMS

**WHEREAS**, the City of Pomona, pursuant to Federal regulations, has prepared, circulated and solicited public input and conducted a public hearing within the City of Pomona, located in the United States, on the 2018-2023 Consolidated Plan and FY 2019-20 Annual Action Plan with proposed funding;

**WHEREAS,** the City of Pomona, after due consideration and review, has complied with the necessary Federal, State and local regulations and requirements; and

**WHEREAS**, the approvals herein are final for inclusion in the FY 2019-2020 Annual Action Plan.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Pomona, as follows:

<u>SECTION 1</u>. That the City Council approves the recommended funding amounts for projects funded under the Federal Entitlement Programs of CDBG and ESG, as indicated in Exhibits A and B.

<u>SECTION 2</u>. That the City Council hereby authorizes adding the recommended funding amounts, reflected in Exhibits A and B, to the Annual Action Plan to be submitted to the Department of Housing and Urban Development (HUD) for FY 2019-2020 for the Federal Entitlement Programs.

**SECTION 3.** That the City Council hereby approves awarding \$87,600 in Emergency Solution Grant to Volunteers of America Los Angeles, under the current site operator agreement for the Hope for Home Service Center, to reserve six crisis beds and report operational data.

<u>SECTION 4.</u> That the City Council hereby approves the inclusion of funding recommendations under the HOME Program into the Annual Action Plan and appropriation of the same in the FY 2019-20 City Operating Budget for FY 2019-2020.

<u>SECTION 5</u>. That the City Council authorizes the City Manager, or her designee, to execute all documents related to the Fiscal Year 2019-2020 CDBG, HOME, and ESG Entitlement Programs.

**<u>SECTION 6</u>**. That the City Clerk shall attest and certify to the passage of this resolution and it shall thereupon take effect and be in full force.
