RESOLUTION NO. 19-1379 - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2018-19 OPERATING BUDGET BY APPROPRIATING \$93,000 IN LOW-MODERATE INCOME HOUSING ASSET FUND BALANCE FOR THE CONTINUED OPERATION OF THE TRANSITIONAL STORAGE CENTER (TSC) BY VOLUNTEERS OF AMERICA LOS ANGELES FROM JANUARY 1, 2019 THROUGH JUNE 30, 2019;

WHEREAS, the City of Pomona has agreed upon actions in a settlement agreement in the case captioned Kelly Allen, et al. v. Pomona, which require expenditures for the operation of a Transitional Storage Center that need to be included in the 2018-2019 Operating Budget;

WHEREAS, it has been determined that the City is able to utilize Low-Moderate Income Housing funds for operation of the Transitional Storage Center (TSC); and

WHEREAS, an appropriation of \$93,000 is required to administer the Transitional Storage Center; and

WHEREAS, on July 17, 2017, the City Council awarded a contract to Volunteers of America Los Angeles (VOALA) as the selected qualified operator of the Homeless Services Center (also known as, the Hope for Home Service Center) for an initial 5-year period; and,

WHEREAS, on December 5, 2018, the Hope for Home Service Center opened and the TSC transferred to this site and its administration was incorporated into the existing Shelter Operator Agreement with VOALA; and,

WHEREAS, the Pomona City Charter requires that amendments to the Adopted Annual Operating Budget be approved by City Council by Resolution.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. Amend the FY 2018-19 City Low-Mod Housing Asset Fund (131-6201-52285-00000) by appropriating \$93,000 from fund balance for continued operation of the Transitional Storage Center, by VOALA, from January 1, 2019 through June 30, 2019.

SECTION 2. That the City Clerk shall attest and certify to the passage and adoption of this Resolution and it shall become effective immediately upon its approval.
