

RESOLUTION NO. 2019- 58**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, ADOPTING A RESOLUTION TO AMEND FY 2018-19 BUILDING AND SAFETY OPERATING BUDGET BY INCREASING REVENUES BY \$478,696 AND APPROPRIATION BY \$311,152.**

WHEREAS, the City Council adopted the operating and capital improvement program budgets of the City of Pomona for fiscal year 2018-2019 on June 4, 2018 and June 18, 2018 and all appropriations for departments or major organizational units within the General Fund and all operating funds and capital improvements programs were approved;

WHEREAS, the City Council approved amendments to the fiscal year 2018-2019 General Fund Operating budgets on March 18, 2019.

WHEREAS, the City Council must approve to amend the Building and Safety revenue fund for the FY 2018-19 operating budget by increasing the revenue budget by \$478,696

WHEREAS, the City Council must approve to amend the FY 2018-19 Building and Safety Operating Budget by Increasing Appropriations by \$311,152

WHEREAS, pursuant to the Pomona City Charter requires that amendments to the Adopted FY 2018-19 Fiscal Budget be approved by City Council by Resolution.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The adopted FY 2018-2019 City operating budget is hereby amended to reflect changes to revenue budget and appropriations as follows:
