A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING THE EXCHANGE OF SERIES AW TAXABLE BOND PROCEEDS IN THE AMOUNT OF \$84,000 FOR PROPOSITION A FUNDS IN THE AMOUNT OF \$120,000 WITH THE CITY OF HIDDEN HILLS AND TO RECEIVE AND APPROPRIATE \$120,000 OF PROPOSITION A FUNDS IN THE FY 2018-19 OPERATING BUDGET; AMENDING THE FY 2018-19 CIP BUDGET BY UN-APPROPRIATING \$120,000 IN SERIES AW TAXABLE BOND PROCEEDS FROM "POMONA TRANSIT BRIDGE IMPROVEMENTS AND BEAUTIFICATION," PROJECT #428-2590-XXXXX-67927 AND APPROPRIATING \$120,000 FROM PROPOSITION A FUNDS TO THE PROJECT

WHEREAS, the City of Pomona wishes to transfer \$84,000 of Series AW Bond proceeds to the City of Hidden Hills; and

WHEREAS, the City of Hidden Hills has offered to assign \$120,000 in Proposition A Funds to be deposited and appropriated to the City of Pomona's Proposition A fund for uses as designated by Proposition A guidelines, thereby amending the FY 2018-19 operating budget; and

WHEREAS, the City of Pomona wishes amend the FY 2018-19 CIP Budget by unappropriating \$120,000 of Series AW Taxable Bond Proceeds from "Pomona Transit Bridge Improvements and Beautification," Project #428-2590-XXXXX-67927 and appropriating \$120,000 of Proposition A funds to the project; and

WHEREAS, if both City Councils and the MTA do not approve such a transaction, the exchange will not take place;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council authorizes the exchange of Series AW Taxable Bond Proceeds of \$84,000 for Proposition A funds of \$120,000 with the City of Hidden Hills at an exchange rate of 70%; and

<u>SECTION 2</u>. The City Council authorizes the City Manager to execute necessary contracts to accomplish the exchange of Series AW Taxable Bond Proceeds from the City of Pomona for Proposition A funds from the City of Hidden Hills; and

SECTION 3. The City Council amends the FY 2018-19 operating budget by receiving and appropriating \$120,000 in Proposition A funds; and

<u>SECTION 4</u>. The City Council amends the FY 2018-19 CIP budget by unappropriating \$120,000 in Series AW Taxable Bond Proceeds from "Pomona Transit Bridge Improvements

<u>SECTION 5</u>. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
