MAYOR/COUNCILMEMBER COMMUNICATIONS

The Mayor and Councilmembers reported on conferences, seminars, and regional meetings attended and announced upcoming events.

CITY MANAGER COMMUNICATIONS

City Manager Linda Lowry proposed to the City Council dates in May to hold a joint meeting with the Planning Commission to discuss the Cannabis Ordinance and the agreement with the Fairplex.

The City Council agreed on setting the meeting to Wednesday, May 1, 2019, meeting time to be determined.

City Manager Linda Lowry yielded this time to Neighborhood Services Director Benita DeFrank to give an overview of the closure of the L.A. County winter shelter.

Neighborhood Services Director Benita DeFrank provided the City Council with an update on the steps taken to notify the public and to close the Los Angeles County winter shelter.

PUBLIC PARTICIPATION

Robert Larry Gordon, Fairplex, spoke on Care Harbor an event taking place at the Fairplex on April 27, 2019.

<u>Nancy Hanna</u>, Pomona, spoke on a citation received from the Code Enforcement Department due to yard maintenance and requested an administrative hearing.

Mayor Sandoval referred Ms. Hanna to speak Deputy City Manager Mark Gluba.

Reverend King, Pomona, spoke on the need for a civilian oversight commission and the Christian Aguilar incident.

<u>Gustavo Ramirez</u> spoke on his organization efforts and his experience with police brutality.

M. Joyce Bakersmith, Pomona, recited statistics published online by the Pomona Police Department and stated she was not in agreement with a police oversight committee.

<u>James Dale</u>, Fairplex, spoke on the Care Harbor event at the Fairplex which will provide free medical, vision, dental and veterinary care; he thanked the Supervisor Hilda Solis, City Staff, Councilmembers Garcia, Ontiveros-Cole, and Mayor Sandoval for their support.

<u>Jim Sanbrano</u>, Latino/a Roundtable, spoke on the 15th Annual Cesar E. Chavez Breakfast and the Assembly Bill 1421 that went into effect on January 1, 2019.

<u>Evelia Rocha</u>, Pomona, spoke on the social media post published by the Chief of Police and expressed her disappointment with the post.

<u>Vanny Yalith Muniz</u>, Pomona, informed the City Council on the dire conditions of the apartment complex where she resided and stated that the rent is increased every six months without any repairs completed to the building.

Mayor Sandoval referred Ms. Muniz to speak with Neighborhood Services Director Benita DeFrank.

<u>Deborah Clifford</u>, Pomona Valley Historical Society, continued her historical summary on Cyrus Burdick.

<u>Erica Loza Vargas</u>, Pomona, expressed over the safety issues at the apartment complex where she lives on Phillips and Palomares.

<u>Jose De Jesus Collardo</u>, Pomona, spoke on the encounter he had with the Pomona Police Department.

Tammy Roush, Fairplex, spoke on upcoming events at the Fairplex.

Mayor Sandoval acknowledged Three Valleys Water Board Member John Mendoza in the audience.

<u>Fernando Romero</u> spoke on the 2020 census and expressed he was in solidarity with those requesting a police oversight commission.

<u>Fabian Pavon</u>, Pomona, stated he was in solidarity with the residents pushing for the police oversight commission, and he spoke on the Cesar E. Chavez Pilgrimage.

Vanessa Guadalupe, Pomona, spoke on Sandra Bland

Randy Bekendam, Amy's Farm, spoke on the dangers of glyphosate.

<u>Francisco A. Suarez</u>, Pomona, spoke on police brutality and expressed he was in favor of a police oversight committee.

<u>Benjamin Wood</u> spoke on the internal affair process and expressed his disappointment on the social media post published by the Chief of police.

<u>Pedro Camacho</u>, PUSH, spoke on several code violations at the apartment complex where he resides, requested assistance from the City Council and a meeting with Councilmember Garcia.

Mayor Sandoval informed Mr. Camacho that the council is working to remedy the situation and that he could show Mrs. DeFrank the photos he brought with him.

<u>Laura Pederson</u>, Pomona, spoke on the Christian Aguilar case and the importance of a police oversight committee.

<u>Edgar Velasco</u>, Pomona, did not wish to speak but informed he was in favor of a police oversight committee.

<u>Yesenia Meza</u>, PUSH, spoke on rent control and rent stabilization and expressed she was not in favor of the Glendale Ordinance because owners could pay the tenants to move out.

<u>Alice Duran</u>, Hope for Home, stated she was a resident at hope for home that has been seeking permanent housing and spoke about the high rental fees.

Elinor Crescenzi, Pomona, invited the public to participate on Pomona Beautification Day.

<u>Jose Calderon</u> expressed his concerns related to public confidence in the police department and suggested looking at other cities who have implemented oversight commissions.

<u>Denise Miranda</u> spoke on her concerns related to the social media post and expressed her support for a police oversight commission.
