

RESOLUTION NO. 2019-62

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, APPROVING AN INCREASE TO THE VEHICLE PARKING DISTRICT QUARTERLY PARKING PERMIT FEES BY FIVE DOLLARS PER MONTH

WHEREAS, in 2012, the Vehicle Parking District Board of Parking Place Commissioners recommended to the City Council adoption of Vehicle Parking District public parking fees, including fees for quarterly parking permits.;

WHEREAS, in 2012, the City Council adopted Vehicle Parking District quarterly parking permit and daily parking fees pursuant to the recommendation of the Vehicle Parking District Board of Parking Place Commissioners;

WHEREAS, Vehicle Parking District parking permit revenues do not meet the on-going operational costs of Vehicle Parking District;

WHEREAS, the current quarterly parking permit fees have not changed since adoption in 2012;

WHEREAS, on February 26, 2019, the Vehicle Parking District Ad-Hoc Committee at their meeting voted to raise quarter parking permit fees by five dollars (\$5) per month and recommend that their decision be presented to the Vehicle Parking District Board of Parking Place Commission for approval;

WHEREAS, on March 14, 2019, the Vehicle Parking District Board of Parking Place Commissioners at their meeting unanimously voted to recommend to the City Council increasing the Vehicle Parking District quarterly parking permits by five dollars (\$5) per month in order to aid in generating revenues to pay for on-going District operational costs;

WHEREAS, Public Notice of the June 3, 2019 Public Hearing was published on May 22, 2019 and again on May 29, 2019;

WHEREAS, the City Council finds it necessary to increase such fees being charged for quarterly parking permits to fund the operation and maintenance of parking facilities in downtown Pomona.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The recitals stated above are true and correct, and the City Council finds that the revenues derived from the parking fees are not used for any purpose other than that related to the operation and maintenance of parking facilities within the Vehicle Parking District.

SECTION 2. That the Quarterly Parking Fee for parking within Vehicle Parking District Lots is hereby increased by the amount of Five Dollars (\$5.00) per month, as set forth in Exhibit “A” attached hereto.

SECTION 3. The City Clerk shall attest and certify to the passage and adoption of this resolution.
