The City Council meeting was called to order at 7:04 p.m.

CLOSED SESSION REPORT

Interim City Attorney Christi Hogan reported that the City Council had convened into Closed Session at 5:32 p.m. with all members present and that the items listed on the agenda had been announced prior to recessing into Closed Session with no public present.

She reported that all the items on the agenda were discussed and that she was not present during the discussion of the City Attorney discussion, and there was no reportable action.

The City Council presented a Certificate of Recognition to Jaime Lepe and his family.

B. A Proclamation of the City Council of the City of Pomona, County of Los Angeles, State of California, Proclaiming the Week of May 19-25, 2019 as "National Public Works Week" in the City Of Pomona

The City Council presented a Proclamation to Interim Public Works Director Rene Guerrero declaring the week of May 19-25, 2019 as National Public Work's week.

MAYOR/COUNCILMEMBER COMMUNICATIONS

Councilmember Gonzalez spoke on several events he attended the past week and over the weekend, which included the opening of Senor Sushi, the Garey High School and Ganesha High School JROTC Ball, the Second Saturday Art Walk, art festival at SAE, and the End Poverty Bus Tour hosted by Senator Connie Leyva.

Councilmember Ontiveros-Cole spoke on the Alejandro Aranda event last week in Pomona and stated it was a well-attended event; she informed that she attended the Conga event at Pomona High.

Councilmember Torres informed that he had attended a Contract Cities and stated he was fortunate to hear legislatures speak and some members of law enforcement on possible on behalf of cities on laws such as AB109 and Prop 47; he also informed the public of an upcoming town hall meeting on May 30, 2019, at 6:30 p.m. at Palomares Community Center and encouraged the residents to attend and voice their concerns.

Councilmember Garcia commented that Pomona is a city with an immense talent she attended the Oscars hosted by Garey High School Viking Music; she informed that she would be hosting a Worker's Right's class in collaboration with the Pomona Economic Opportunity Center at Washington Park on May 22, 2019, at 5:30 p.m.

Councilmember Preciado extended his congratulations to the students promoting and graduating in the City. He also spoke on the Public Works event held today in honor of National Public Works Week.

Councilmember Lustro spoke on Alejandro Aranda Day and thanked City Staff, the DPOA and the Tessier Family for allowing the Fox theatre to be used for the event; he also informed that he attended the American Idol watch Party hosted at the Fox Theatre on Sunday.

Mayor Sandoval exclaimed that Alejandro Aranda Day was a historic day in the City, people from all over the world were watching, and it was a Beautiful display of the City; he also stated that any questions or concerns related to cannabis are welcome and that a decision has not been

finalized. He informed that community meetings would be held throughout the city, allowing residents the opportunity to voice their concerns.

Virginia Beltran, Pomona, spoke on convicted child molesters and their proximity to neighborhood churches.

Erik Delgado, Pomona, International Brotherhood of Electrical Workers, IVEW was in the process of searching for a training hall, and he wished to introduce himself and the organization to the City Council and community.

Ivan De Herrera, Assistant Business Manager of IBEW, spoke on the trades that are available at IBEW and their hopes to recruit more students to train.

Deborah Clifford, Pomona Valley Historical Society, shared a brief history on Jose Antonio Perez, the "last vaquero."

Selena Pacheco, Grid Alternatives, informed that Grid Alternatives in conjunction with Southern California Edison would be sending out mailers to the community regarding the qualifications and programs.

Dee Ybarra, Murdered Missing Indigenous Women (MMIW), spoke on the high murder rate for indigenous people, specifically for indigenous women.

Carlos Goytia, Pomona, spoke on the disappearance of native women and the need to raise awareness.
