

RESOLUTION NO. 2019-88

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, APPROVING THE CITY MANAGER, HUMAN RESOURCES/RISK MANAGEMENT DIRECTOR AND FINANCE DIRECTOR/CITY TREASURER AS AUTHORIZED AGENTS FOR THE PURPOSE OF OBTAINING CERTAIN FEDERAL AND STATE FINANCIAL ASSISTANCE FOR DISASTERS TO BE KEPT ON FILE WITH THE CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES

WHEREAS, the California Governor's Office of Emergency Services administers the Hazard Mitigation Grant and Pre-Disaster Mitigation Grants programs:

WHEREAS, the City may be eligible for federal financial assistance under Public Law 93-288 as amended by the Robert T. Stafford Disaster Relief and Emergency Assistance Act of 1988, and/or state financial assistance under the California Disaster Assistance Act;

WHEREAS, in order to obtain said financial assistance, the City of Pomona is required to designate three City staff members as Authorized Agents for the City;

WHEREAS, once authorized, a list of these Agents will then be forwarded and kept on file with the State of California Governor's Office of Emergency Services; and

WHEREAS, the Authorized Agents can execute for and on behalf of the City of Pomona, any actions necessary for the purposes of obtaining state financial assistance provided by the California Governor's Office of Emergency Services.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Pomona as follows:

SECTION 1. That the City Council hereby names the City Manager; Human Resources/Risk Management Director and the Finance Director/City Treasurer as the Authorized Agents to execute for and on behalf of the City of Pomona any actions necessary for the purpose of obtaining financial assistance provided by the California Governor's Office of Emergency Services.

SECTION 2. That the City Manager; or Human Resources/Risk Management Director; or the Finance Director/City Treasurer is hereby authorized to execute for and on behalf of the City of Pomona, a public entity established under the laws of the State of California, the application included in Exhibit A and to file it with the California Governor's Office of Emergency Service for the purpose of obtaining certain federal financial assistance under Public Law 93-288 as amended by the Robert T. Stafford Disaster Relief and Emergency Assistance Act of 1988, and or state financial assistance under the California Disaster Assistance Act.

SECTION 3. That the City of Pomona, a public entity established under the laws of the State of California, hereby authorizes its agent(s) to provide the California Governor's Office of

Emergency Service for all matters pertaining to such state disaster assistance the assurances and agreements required.

SECTION 4. The City Council authorized the City Manager to approve any additional actions or documents that may be necessary to designate said positions as Authorized Agents.

SECTION 5. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its adoption.
