PLEDGE OF ALLEGIANCE

Veteran Pete D. Garcia led the Pledge of Allegiance to the Flag.

PRESENTATIONS

A. Proclamation proclaiming the week of March 18-24, 2019 as "Fix A Leak Week" in the City of Pomona

Councilmember Torres and the City Council presented the Proclamation to Water Resources Director Darron Poulsen and Environmental Programs Supervisor Julie Carver.

B. Recognition of Diamond Ranch High School's Girls Basketball Team for Capturing the CIF Southern Section 3A Championship and Reaching the Second Round in the State Tournament

Councilmember Lustro and the City Council presented the Certificate of Recognition to the Diamond Ranch High School's Girls Basketball Team.

Principal Suzanne Steinseifer-Ripley thanked the City for recognizing the team and announced that Coach Kearney Lindsey was awarded Coach of the Year for Division 3A; Erin Cha, a senior at Diamond Ranch, was named Player of the Year, and Kennedy Lindsay, a junior at Diamond Ranch, was named to the All CIF Team.

MAYOR/COUNCILMEMBER COMMUNICATIONS

Councilmember Preciado thanked Councilmember Lustro for a successful Spring clean-up-Thanked CM Lustro for a successful Spring Clean-up, Labor United Against Cancer Walk put on by the UFCW 1428 in San Dimas.

Councilmember Ontiveros-Cole spoke on the Tuesday cleanup at Village Academy; she also spoke on the upcoming event for the Love of Car taking place on Saturday, June 8, 2019, from 10 a.m. to 3 p.m.

Councilmember Gonzalez spoke on his attendance at various Pomona Unified School District school for the Read Across American event; he also spoke on the Pomona Heritage Dinner, the G2G Boxing event with Tito Mercado and on Green Ribbon Week for mental health awareness.

Councilmember Lustro commented on his participation in the Read Across America event and the STEAM FAIR at the Fairplex with Bill Nye the Science Guy. He informed that the District 5 town hall meeting would be held on Thursday, March 28, 2019, at 7:00 p.m. at the Westmont Community Center.

Councilmember Garcia thanked the learning centers at the Fairplex for allowing her to be the Dr. Seuss reader to the kindergarten students.

Councilmember Ontiveros-Cole thanked the Mayor for attending the Tribute of Courage at the Sheraton honoring first responder one which was Trevor Stevenson, a Pomona police officer.

Mayor Sandoval shared that Bright Prospect was recognized online by Time Magazine as an organization helping disadvantaged youth get accepted into college.

CITY MANAGER COMMUNICATIONS

City Manager Linda Lowry informed she did not have anything to report.

PUBLIC PARTICIPATION

<u>Douglas C. Pierce</u>, Pomona, spoke about his health and stated he hoped to be present at future Council meetings.

<u>Hennesey Woods</u>, Justice 4 Youth, invited the City Council to an event title Influence on Friday, March 29, 2019, at 7:00 p.m. located at 158 W. Third Street, and explained it that the event focuses on helping the youth develop leadership growth.

<u>Edgar Velasco</u>, former Pomona resident, informed he had moved out of Pomona due to the increase in rents, and requested that the City Council consider a form of rent control to help maintain the communities in Pomona.

Mayor Sandoval reminded review the Rental Ordinance passed by the City of Glendale and similar Ordinances to review options for the City of Pomona.

Jim Sanbrano was not present to speak.

<u>Andrea Casillas</u>, Pomona Student's Union, spoke on the youth commission and the importance of allocating funds for youth programs.

Mayor Sandoval commented that there had been an initial meeting with the youth to gather their input regarding the Youth Commission and that there would be a follow up meeting on March 29, 2019.

<u>Cielo Castro</u>, Fairplex, announced the upcoming events at the Fairplex.

Laura F. Pedersen, Pomona Democratic Socialists of America, spoke on the Christian Aguilar case and requested that City Council create a committee to revise the City Charter to include a civilian police oversight board with investigatory and disciplinary power.

<u>M. Joyce Bakersmith</u>, Willie White Park Focus Group, spoke on the Neighborhood Watch Meeting the focus group would be hosting and invited the Council to attend; she also on the condition of the roofs at the community center.

Mayor Sandoval requested a report from Staff outlining the City's options regarding maintenance relating to City buildings.

Virginia Vietta Sifuentes, Pomona, spoke on civil rights and accountability from Police Department.

<u>Yesenia Miranda Meza</u>, Co-founder of Pomona United for Stable Housing, spoke on the need for rent control in the City of Pomona; she thanked Councilmember Garcia for allowing the use of Washington Park Community Center to have the community forum; she requested to meet with the City Council to discuss solutions for rent stabilization in the City.

<u>Deborah Clifford</u>, Pomona Historical Society, summarized the history on Cyrus Burdick, one of the three men that started the City making process for Pomona.

<u>Julianna Pina</u>, Justice 4 Youth, spoke on reinstating the youth commission and the importance of youth programs.

<u>Raymond Harrison</u>, Self Help Credit Union, spoke on the similarities of the City's and credit union's mission statement and how he would like to partner together with the city and reinvest money back into the City of Pomona.

<u>Catia Plascencia</u>, Pomona, thanked the City Council Councilmember Torres for bringing approving and quickly placing a crossing guard at Harrison Elementary; Ms. Plascencia along with her children presented a Certificate of Appreciation to Councilmember Torres and the City Council on behalf of the students at Harrison Elementary.

John Mendoza, Three Valleys Water District, declared that he was in support of the MOU between the City of Pomona and the Inland Empire Utilities Agency.

Citizens Oversight Committee Bylaws

It is recommended that the City Council review and approve the proposed Citizens Oversight Committee Bylaws.

<u>Anne Tomkins</u>, Pomona, informed that she had reviewed the bylaws and did not note any changes she had addressed at the prior meeting. She stated that a section should be included

allowing for the amendment of bylaws, the agenda should include a Public Participation section, and that the 6/7 vote for the election of a Chair could prove to be difficult.

Mayor Sandoval and Councilmember Lustro inquired about specific amendments to the bylaws and City Manager Linda Lowry informed that for the initiation of the Commission the bylaws would be amended to state a 4/3 vote for the election of the Chair; she also informed that because the committee follows the Brown Act, Public Participation is standard but that the bylaws would be amended to include on the agenda.

City Manager Linda Lowry clarified that the number of meetings set conforms to the intention of the Ordinance presented to the voters and explained the purpose of the committee.

Mayor Sandoval advised that the committee could request from the City Council to hold more meetings throughout the year if they felt it was necessary.

Councilmember Preciado requested that Staff hold an orientation meeting for the committee prior to their first official meeting.

MOTION BY COUNCILMEMBER PRECIADO, SECOND BY COUNCILMEMBER ONTIVEROS-COLE, CARRIED 7-0, to adopt the Bylaws as presented with an amendment provision added to include Public Comment listed as part of the regular agenda, and with a notation that they 6/7th vote requirement did not apply to the initial formation of the committee.

10. Proposed Phillips Ranch Zone AB Assessment District Service Level Increase Options

It is recommended that the City Council take the following actions:

1) Receive and file the City of Pomona Benefit Analysis for Phillips Ranch dated February 26, 2019 prepared by NBS Government Finance Group; and

2) Select a service level/assessment option as described in the "Alternatives" section of the staff report; and

3) Adopt the following resolution:

RESOLUTION NO. 2019-29 - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA INITIATING PROCEEDINGS PURSUANT TO THE LANDSCAPING AND LIGHTING ACT OF 1972 TO FORM THE PHILLIPS RANCH LANDSCAPING AND LIGHTING MAINTENANCE ASSESSMENT DISTRICT, DESCRIBING THE PROPOSED IMPROVEMENTS TO SERVE SAID DISTRICT, AND ORDERING THE PREPARATION OF THE ENGINEER'S REPORT

Acting Public Works Director Rene Guerrero provided a brief presentation on the item; he thanked the Chair Dennis Chiapetta, Co-Chair Scott Harmon, Outreach Coordinator Brian Mundy, and the committee members; he informed that the Chair and Co-Chair were available to answer questions; he continued to thank Public Works Staff for their input and assistance.

Adina McCargo gave a presentation to the City Council regarding the process.

Councilmember Torres inquired and Ms. Mccargo explained that the City Council will choose an option that is presented to the residents and the residents are given an opportunity to protest the option; she further explained the that the rates had not been adjusted since 1994.

City Manager Linda Lowry commented that the Phillips Ranch Community had accumulated a reserve in the Phillips Ranch Assessment District fund and that the reserve had been used to sustain the cost increase throughout the years; however, when the City began experiencing fiscal issues the reductions had to come down to service level; she informed that any past attempts to have the fees raised had not been successful.

Mayor Sandoval expressed the importance of the fee increase passing to meet the expectations of homeowners in the Phillips Ranch District and to maintain property values.

Councilmember Lustro commented that if the community chose to not pass the fee increase the service levels would continue to decrease; he stated that neither he nor the committee expected the City to bail out the Assessment District and that it was important that community members use their best judgement as to how they want the community to look in the future.

Councilmember Torres inquired and Ms. McCargo informed that the committee had been utilizing social media outlets to reach the community and that a legal notice was provided by the City.

Outreach Coordinator Brian Mundy spoke on the community outreach initiated by the Ad-Hoc Committee.

MOTION BY MAYOR SANDOVAL, SECOND BY COUNCILMEMBER LUSTRO, CARRIED 7-0, to receive and file the Engineer's Report, select Alternative 2 - To propose to the community of District 5 to vote on: Increase the 2019-20 assessment to the level it would have been had the CPI been included from 1994 to 2018, and then increase the assessment amount by CPI annually beginning in July 2022 based on the change between the 2021 and 2022 CPI.

11. Regulation of Commercial Cannabis Businesses

It is recommended that the City Council take the following actions:

1) Waive further reading and introduce on first reading the following ordinance:

ORDINANCE NO. 4257 - AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE POMONA CITY CODE BY ADDING CHAPTER 68, "COMMERCIAL CANNABIS BUSINESSES"

2) Direct staff to draft proposed zoning ordinance amendments to allow certain commercial cannabis businesses in specified zones to be heard by the Planning Commission and direct that the Commission conduct a public hearing and make recommendations regarding the amendments; and

3) Direct staff to present the Planning Commission's recommendation on amendments to the Zoning Code to address Commercial Cannabis Uses, in the form of an ordinance, to the City Council at a duly noticed public hearing; and

4) Direct staff to prepare and present for Council consideration of a resolution establishing the maximum number and types of commercial cannabis businesses to be allowed in specified zones and a resolution adopting a Process Integrity Standards.

<u>John Mendoza</u>, District 6 resident, felt it was unfair to only provide the option to opt out from dispensaries to one district; he commented he was not in agreement with an independent evaluator and expressed that if any member of the Council was not in full agreement with the Ordinance they should oppose the Ordinance.

Jean Marc Apalategui, did not wish to speak but stated he was in opposition.

Nathan R. Plascencia, did not wish to speak but stated he was in opposition.

<u>David Knight</u>, Pomona, questioned whether a church fell into the category as a place of learning and stated he was under the impression that dispensaries could not setup to sell near places of learning.

<u>Patrick B. O'Grady</u>, Father at St. Peter the Apostle Church, expressed he was disturbed by the news that there would be a possibility that dispensaries could be located near churches; he commented that the same distance from schools should apply to churches.

<u>Douglas B. Law</u>, Pomona, stressed that the City should find appropriate locations in the City to allow dispensaries and that they should not be located near churches.

<u>Catalina Gonzalez</u>, Day One Prevention Director, spoke on her concerns regarding the lack of public health regulation and operation requirements that they felt were missing from the draft ordinance; she spoke on the number of businesses that should be allowed.

<u>Judith St. John</u>, Pomona, agreed with the need to be concerned for the youth; she spoke on prohibiting the advertising of cannabis on billboards. She stated she was in favor of Councilmember Torres' recommendation to allow the City Council to submit comments; she submitted a petition that included 56 signatures of residents in district six that were in agreement that the Fairplex should not allow any cannabis activity.

<u>Mark Ramos</u>, spoke in favor of the ordinance and commented that the Ordinance is designed to keep children safe and to put a stop to illegal dispensaries and deliveries.

The City Council reviewed the draft Ordinance as outlined in the written Staff report. They discussed items one (1) through six (6) which were items raised at the March 4, 2019, City Council meeting.

Following discussion, Mayor Sandoval and Councilmembers Gonzalez, Preciado, Garcia, Ontiveros-Cole, and Lustro did not support Item one (1) adding the language related to Councilmember Participation. Councilmember Torres was in favor of adding the Councilmember Participation language to the Ordinance. The City Council supported adding items two (2) through six (6) to the draft Ordinance.

MOTION BY MAYOR SANDOVAL, SECOND BY COUNCILMEMBER GONZALEZ, CARRIED 6-1 (COUNCILMEMBER TORRES OPPOSED), Introduce on First Reading and the Amendment of Deleting Section 68-9F an Ordinance of the City of Pomona Amending the Pomona City Code by Adding Chapter 68 - Commercial Cannabis Business.

Acting Finance Director Andrew Mowbray briefed the City Council.

During the discussion, the City Council commended Acting Finance Director Andrew Mowbray and staff for putting together a well-written report.

Councilmember Garcia suggested revisiting the reserve fund and raising funds from 17% to 20%, and Mayor Sandoval commented that he would like to see what the service tradeoffs would be if the reserve fund is raised from 17% to 20%.

City Manager Linda Lowry inquired, and the City Council agreed to review a staff report outlining the costs related to deferred maintenance for City-owned properties so that they could discuss which repairs they would like to see move forward.

Councilmember Ontiveros-Cole expressed her concern regarding the Santa Fe Outlet Closing along with other businesses closing down in District 4.

Councilmember Garcia requested that the sidewalk vendor Ordinance be revisited and was in agreement with Vice-Mayor Gonzalez's request to revisit the speed bump moratorium.

Councilmember Lustro inquired whether he could contact Pomona Unified School District teachers to present on their mobile program Footsteps to Brilliance at a future council meeting.

Mayor Sandoval agreed that it was a great program and requested that the process for presentations at future City Council meetings be discussed at the Special Meeting on Monday.

Councilmember Torres expressed his agreement with revisiting the speed bump moratorium; he also inquired about obtaining neighborhood watch signs for District 6.

Mayor Sandoval inquired about the Housing Element, and Acting Director Anita Gutierrez informed that the City was anticipating a letter of conditional approval shortly.
