Status Update on Code Enforcement Cases for Recycling Facilities and Other Industrial Uses - Receive and File

John Mendoza spoke on the recycling crisis in California.

Mark Gluba, Deputy City Manager, and Anita Gutierrez, Development Services Director, answered questions from the Council.

Council gave direction to bring this item back with recommendations for a zoning code amendment to regulate these businesses and a report of what other agencies responsibilities are to enforce safety issues beyond the scope of the City's Code Enforcement department.

No action vote was taken on this item.

6. Approval of Letter of Agreement with Fairplex Regarding Processing of Specific Plan Application and Interim Use of Property

It is recommended that the City Council approve the letter agreement and authorize Mayor to execute on behalf of City

Eunice Russell spoke on her concerns with the language of the agreement.

Alfred Fraijo, counsel for Fairplex, spoke on the agreement and explained that the stakeholders referred to in the agreement would be appointed by Council.

Miguel Santana, CEO Fairplex, said this agreement was the framework to move forward, the fund established in the agreement would address the needs of the surrounding neighborhood of the Fairplex and that Fairplex is open to further discussion and collaboration from residents.

7. Consideration of Disposition of the City Stable

It is recommended that the City Council discuss and consider options for the disposition of the City Stable Facility and provide final direction.

Rene Guerrero, Interim Public Works Director, and Darron Paulsen, Water Resources Director gave a presentation on the history of the City Stables.

The Historic Preservation Commission (HPC) Ad-hoc Committee (James Kercheval, Tamara Gonzalez, Jim Gallivan) gave a presentation with their recommendation for the preservation of the City Stables.

Jaqueline Elizalde spoke on Brown Act Violations committed by the Historic Preservation Committee.

Discussion ensued between the Council members, HPC, Risk Manager Chris Millard and Darron Paulsen regarding the options for the City Stables, how much the insurance carrier would cover for the damage claim, how the Water Department project affects the City Stables and further questions that the Council wanted answered before they would make any decisions.

The consensus of the Council was the desire to save the historic Stables but also to be fiscally responsible. Councilmembers Preciado and Lustro expressed their opinion that saving the Stables should not be the responsibility of the Water Department. Councilmember Gonzalez expressed environmental concerns with the site. Darron Paulsen clarified for Councilmember Lustro that the water rate increase has nothing to do

with the cost of the new building. Those fees can legally only go to operations and infrastructure.

Direction was provided to staff with the request to bring this item back at a future meeting. The Mayor advised City Manager Lowry the council needed more information on the following:

- Legal concerns/permitting requirements if building is moved
- Cost analysis for the adaptive reuse whether the building stays or is moved, either as part of the Water Department project or to another site
- Historic designation of the Stables-what happens if it's moved?
- Insurance carrier-what is the amount that would be covered for the Stables rebuild?
- Presentation from Darron Paulsen about the Water Department project and how the total price was figured

The Mayor also requested the Brown Act Violation allegation be investigated by the City Attorney.

No action vote was taken on this item.

8. Finding of Public Benefit of the Community at Large: Recommended Expenditure and Recap of Funds

It is recommended that the City Council take the following actions:
