PRESENTATIONS

- A.** A Proclamation of the City Council of the City of Pomona, County of Los Angeles, State of California, Proclaiming June 2019 as LGBTQ+ Pride Month in the City of Pomona

Mayor Sandoval invited members of the audience to join him and the City Council at the dais as they read the proclamation declaring June as LGBTQ+.

- B.** Recognition of Outgoing Chief Operating Officer and Provost Dr. Gary Gugelchuk for his 36 Years of Service and Loyal Dedication to the Pomona Valley and Inland Empire through his Leadership and Scholarship at Western University of Health Sciences

Mayor Sandoval read the Certification of Recognition recognizing Dr. Gary Gugelchuk for his 36 years of service at Western University of Health Sciences.

MAYOR/COUNCILMEMBER COMMUNICATIONS

Councilmember Preciado announced that on Wednesday, June 19, 2019, at Washington Park, there would be a community meeting regarding cannabis. He also informed that on Friday, June 21, 2019, at Palm Lake Golf Course there would be a meeting with the property operators and it would be a great opportunity to receive an update and ask questions related to the project. Lastly he informed that on June 27, 2019, from 6:30 p.m. to 8:30 p.m. at El Jefe restaurant an LGBTQ+ Pride month social.

Councilmember Torres thanked the Pomona Police Department for the Area Commander meeting from the prior week.

Councilmember Lustro spoke on the event For the Love of Cars and expressed that it was a nice event. He also informed that on Saturday, June 22, 2019, Household Hazardous Waste roundup would take place at the Fairplex at Gate 9.

Councilmember Ontiveros-Cole spoke on the event For the Love of Cars thanked everyone that helped make the event possible and she informed that the proceeds went to the Pomona Valley Historical Society.

Councilmember Gonzalez informed he attended the Fairplex community forum, For the Love of Cars event and the Ramadan celebration.

Councilmember Garcia reiterated Councilmember Preciado's comments regarding the cannabis community meeting at Washington Park on June 19, 2019, at 7:00 p.m.

Mayor Sandoval thanked the Pomona Economic Opportunity Center on behalf of Councilmembers Preciado and Garcia for the invitation to their Father's Day event. He informed that the Mayor's Gala was held on Thursday. Mayor Sandoval stated that because of the efforts of Senator Connie Leyva, the Pomona Public Library was receiving \$280,000 in funding and that the gala had raised an additional \$150,000. Mayor Sandoval also spoke on funding that the City received for Concerts in the Park; he also informed that LAHSA released their homeless count numbers for 2019 and that citywide the City of Pomona saw a decrease of 11% in homelessness.

CITY MANAGER COMMUNICATIONS

City Manager Linda Lowry thanked the City Council and previous City Councilmembers for the leadership they displayed in making decisions that would allow the City to make progress on the homeless front.

PUBLIC PARTICIPATION

David Kim, Pomona, expressed his concerns regarding the conditions of city roads.

Mayor Sandoval directed Mr. Kim to speak with Acting Public Works Director Rene Guerrero to discuss which streets are on the list to be repaired.

M. Joyce Bakersmith, Pomona, spoke on the 16th Annual Juneteenth Festival Potluck taking place on Thursday, June 20, 2019; she informed that Mayor Sandoval is a guest speaker giving the closing message.

Marianne Cintron, Step by Step Dyslexia Solutions, spoke on about her non-profit organization and how they help improve literacy skills for children having trouble reading. Ms. Cintron informed that she was attempting to raise \$15,000 to train five teachers to help the community.

Darrel Kruse, spoke on his efforts operating cannabis dispensaries.

Yesenia Arias, Foothill Gold Line, informed that there would be testing on Sunday, June 22, 2019, from 10:00 a.m. to 8:00 p.m. for the newly installed underground communication system for the freight train system.

Eleni Adoni Mastrakos, USC School of Public Policy, informed the City Council that the school offers a free local elected leaders academy to train elected officials on gaining leadership skills.

Elinor Crescenzi, Pomona, spoke on the Pomona Valley Certified Farmer's Market and the increase of farm vendors who have joined the market.

Allan Yang, Police Learning Center, spoke on developing a program where police officers can interact with students in a community based education system.

Yesenia Miranda Meza, Pomona United for Stable Housing, announced that their community group held elections for the board and she had been elected as President and former Councilmember John Nolte had been chosen as Vice President.

Lucas Rivera, Fairplex, spoke on upcoming events at the Fairplex and events that they helped sponsor throughout the community; he also spoke on the annual job fair taking place on Thursday, June 20, 2019, to fill positions for the Los Angeles County Fair.

Anel Hernandez, PUSH, announced she had been selected as the secretary for PUSH and also spoke on the need for affordable housing and helping the residents of Pomona.

Howard Hernandez, American Legion Post 30, announced he had been elected as the new commander for Post 30 and spoke on his vision to have VA Veteran Center in west Pomona.

Jesse Villanueva, Pomona, invited the City Council and the community to the 4th of July event at Post 30 and spoke on the success of the Memorial Day event.

Jose Diaz, PUSH, spoke on affordable housing and on attempting to resolve housing issues tenants have been experiencing.

Benjamin Wood commended the City for the LGBTQ+ proclamation and expressed that it goes a long way to show the community is diverse; he also stated that he had been elected to the PUSH Board and he also spoke on the police accountability.

Darlene Johnson, Pomona, expressed her concerns on loitering issues taking place at 630 East Arrow Hwy.

15. Allegation of Brown Act Violation by Historic Preservation Commission

It is recommended that the City Council take the following actions:

1) Admonish the members of the Historic Preservation Commission to only discuss Commission business during property noticed meetings and specifically to refrain from using Nextdoor or any social media to discuss matters within the Commission's subject matter jurisdiction; and

2) Direct the City Clerk to provide a copy of "Guidelines to Prevent Serial Meetings" to each member of a City commission or committee subject to the Brown Act.

Interim City Attorney Christi Hogin gave a brief presentation on this item to the City Council and explained Staff's recommendations and informed that these situations are taken seriously as it sets the bar to making government transparent.

Mike Suarez, stated that he had served as a commissioner and stressed the importance of following the Brown Act and representing Pomona with honesty and forthright.

Jacqueline Elizalde, Pomona, spoke on the Brown Act violation committed by the Historic Preservation Commissioners on social media; she also expressed her concern over remarks that were made by a Commissioner on social media and requested that two Commissioners have their appointment to their respective commission rescinded.

During the discussion Interim City Attorney Christi Hogin clarified that the serial meeting was a civil violation because there was no intent to keep the public from the conversation since it was on a public forum. The civil issue is designed to keep the City out of court and designed to allow for a cure of the violation, which that cure outlined in the staff report.

MOTION BY MAYOR SANDOVAL, SECOND BY VICE-MAYOR PRECIADO, CARRIED 7-0, approving Staff's recommendation.

16. Report back on possible land use options pertaining to legal nonconforming recycling facilities.

It is recommended that the City Council review this report; and

Direct staff to prepare a code amendment to the nonconforming Section of the Pomona Zoning Code to shorten the time frame in which a use can be discontinued from two years to 180 days.

Development Services Director Anita Gutierrez provided a presentation to the City Council.

Elinor Crescenzi expressed her gratitude to the City Council for following up on this issue and stated she was in favor of reducing the time frame from two years to 180 days.

Councilmember Garcia discussed her concerns, and they were addressed by Staff.

Councilmember Lustro thanked Staff for the summary and outline in the report and stated he agreed with Staff's recommendation.

MOTION BY COUNCILMEMBER LUSTRO, SECOND BY COUNCILMEMBER GARCIA, CARRIED 7-0, directing Staff to prepare a code amendment to the nonconforming Section of the Pomona Zoning Code to shorten the time frame in which a use can be discontinued from two years to 180 days.

Development Services Director provided a detailed presentation to the City Council.

Elinor Crescenzi expressed her concern over the need to have integrated areas where there is the ability to grow food, individuals can train for farm jobs and where the food could be used to provide food for the shelters.

Councilmember Garcia inquired and Interim City Attorney Christi Hogin stated she was confident that the Housing Element Staff had prepared was in compliance with the state law.

The City Council thanked Staff for standing firm and for doing a good job with the given resources.

MOTION BY MAYOR SANDOVAL, SECOND BY COUNCILMEMBER GARCIA, CARRIED 7-0, approving Resolution No. 2019-73 - Approving the addendum to the General Plan Environmental Impact Report and Adopting Revisions to the 2013-2021 Pomona Housing Element. Waive the first reading, read by title only and introduce Ordinance No. 4263 Approving Amendments to the Pomona Zoning Code, Pomona Downtown Specific Plan, Pomona Corridor Specific Plan, Ordinance No. 4224 and Ordinance No. 4238 relating to emergency shelter locations and standards, minimum density requirements and parking ratios and Authorize the Director of Development Services to make non-substantive clarifications or corrections to the Housing Element in the event the California Department Housing and Community Development (HCD) makes such a request
