WHEREAS, the Heroes of Pomona Speech Contest was designed to provide 100 or more participants in the After School Recreation Program with meaningful opportunities to develop valuable communication and public speaking skills;

WHEREAS, the Tri-City Mental Health Services Community Wellbeing Grant will provide the financial resources needed to administer the Heroes of Pomona Speech Contest project; and

WHEREAS, California law and the Pomona City Code (Chapter 2, Article VI, Division 5) set forth the method for establishing and increasing fees charged to recover costs reasonably borne by the City in providing services; and

WHEREAS, the grant funding being received must be appropriated through an amendment to the Fiscal Year 2019-20 Operating Budget. The Pomona City Charter requires budget amendments to be approved by City Council resolution.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

<u>SECTION 1</u>. That the City Council accepts the Tri-City Mental Health Services Community Wellbeing Grant Award to carry out the Heroes of Pomona Speech Contest.

<u>SECTION 2</u>. That the Fiscal Year 2019-20 Miscellaneous Grants Operating Budget shall be amended by appropriating \$7,500 (215-4190-XXXXX-58687).and revising the corresponding revenue estimate in the same amount of \$7,500 (215-4190-40380-58687).

<u>SECTION 3</u>. The City Clerk shall attest to the passage of this resolution, and it shall become effective immediately upon its adoption.
