

RESOLUTION NO. 2019-95

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING APPENDIX B OF THE MEMORANDUM OF UNDERSTANDING WITH THE POMONA CITY EMPLOYEES' CHAPTER OF THE TEAMSTERS LOCAL 1932 (PCEA/TEAMSTERS) AND AUTHORIZED STAFFING LEVELS IN THE FISCAL YEAR 2019/20 ADOPTED OPERATING BUDGET BY CHANGING THE TITLE OF HOUSING TECHNICIAN TO HOUSING TECHNICIAN II, ADDING THE CLASSIFICATION OF HOUSING TECHNICIAN I, AND RECLASSIFYING THREE HOUSING TECHNICIAN POSITIONS TO THE FLEXIBLE STAFFING CLASSIFICATION OF HOUSING TECHNICIAN I/II

WHEREAS, the City Council has the authority to create, classify and assign salary scales/ranges for Pomona City Employees' Association positions for the City of Pomona;

WHEREAS, the City Council has the authority to amend the staffing allocations;

WHEREAS, on April 23, 2018, the City Council adopted Resolution No. 2018-34 adopting the 2017-2019 Memorandum of Understanding (MOU) between the City of Pomona and the Pomona City Employees' Chapter of the Teamsters Local 1932 (PCEA), which also established a Roster of PCEA General Service Classifications;

WHEREAS, the City Council adopted the operating budget of the City of Pomona for Fiscal Year 2019-2020 on June 3, 2019, which included the authorized Citywide staffing allocations; and

WHEREAS, the City Council desires to amend Appendix B of the aforementioned MOU and further amend the authorized staffing allocations by the actions herein.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona, California, as follows:

SECTION 1. That the City Council hereby amends Appendix B of the PCEA MOU by deleting the Housing Technician classification and creating the Housing Technician I/II flexible staffing classification as follows:

*Flexible staffing classification

SECTION 2. That the City Council hereby approves amending authorized staffing levels for the Neighborhood Services Department within the Fiscal Year 2019/20 Operating Budget by reclassifying three (3) Housing Technicians to Housing Technician I/II flexible staffing positions.

SECTION 3. That any portion of previously adopted resolutions concerning salaries inconsistent with this Resolution shall be deemed repealed.

SECTION 4. The actions approved herein shall become effective July 21, 2019.

SECTION 5. The City Clerk shall certify to the passage and adoption of this resolution, and it shall thereupon be in full force and effect.
