

RESOLUTION NO. 2019-96

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING APPENDIX A OF THE COMPENSATION PLAN FOR EXECUTIVE MANAGEMENT GROUP A AND B EMPLOYEES AND AUTHORIZED STAFFING LEVELS IN THE FISCAL YEAR 2019/20 ADOPTED OPERATING BUDGET BY ADDING THE CLASSIFICATION OF CODE COMPLIANCE MANAGER AND RECLASSIFYING THE SENIOR CODE COMPLIANCE INSPECTOR POSITION TO CODE COMPLIANCE MANAGER.

WHEREAS, the City Council has the authority to create, classify and assign salary scales/ranges to the Personnel Rules and Regulations for Executive Management Group A and B Employees (A-B Rules) of the City of Pomona;

WHEREAS, the City Council has the authority to amend the staffing allocations;

WHEREAS, on September 17, 2018, the City Council adopted Resolution No. 2018-136 amending the A-B Rules;

WHEREAS, the City Council adopted the operating budget of the City of Pomona for Fiscal Year 2019-2020 on June 3, 2019, which included the authorized Citywide staffing allocations; and

WHEREAS, the City Council desires to amend Appendix A of the aforementioned A-B Rules by adding a classification and further amend the authorized staffing allocations by the actions herein.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Pomona as follows:

SECTION 1. That the City Council hereby authorizes changes to be made to Appendix A of the A-B Rules' by adding the classification below.

SECTION 2. That the City Council hereby approves amending authorized staffing levels for the Development Services Department within the Fiscal Year 2019-2020 Operating Budget by reclassifying the Senior Code Compliance Inspector position to Code Compliance Manager.

SECTION 3. That any portion of previously adopted resolutions concerning salaries inconsistent with this Resolution shall be deemed repealed.

SECTION 4. The actions approved herein shall become effective July 21, 2019.

SECTION 5. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its adoption.
