THE POMONA CITY COUNCIL does hereby declare and give notice that a public hearing will be held August 5, 2019, in the City Council Chambers, 505 South Garey Avenue, Pomona, California, commencing at 7:00 p.m. to consider the following:

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA  
AMENDING AND ADOPTING NEW SERVICE FEES FOR INSPECTIONS  
MANDATED BY THE STATE WATER RESOURCES CONTROL BOARD  
FOR THE NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM  
(NPDES) PERMIT AND STATE WATER RESOURCES CONTROL BOARD  
ORDER 2006-0003**

The City is required by the State to conduct water discharge compliance inspections of commercial and industrial facilities, and construction sites, as well as inspect grease producing facilities. Cost-recovery fees in the amounts listed below are being proposed for businesses and construction sites subject to NPDES inspection and/or grease producing facility inspection. If adopted the new inspection fees will allow full cost recovery for administration of the program.
